BACKGROUND:

After each decennial federal census, county board of education trustee areas must be assessed and potentially adjusted in order to meet legally required population criteria. [Education Code 1002(b)] The Sacramento County Board of Education (SCBE) appointed a Redistricting Committee to work on the redistricting process for SCBE Trustee Areas, and contracted with Thomas M. Griffin Law Offices and EdTec Inc. for redistricting services and expertise. Population data from the 2010 Census was analyzed and used to suggest potential adjustments to Trustee Areas in order to ensure compliance with state and federal law. The Redistricting Committee then presented four redistricting options at a public hearing before SCBE on July 12, 2011. Following the public hearing, SCBE approved Option 1A-1 as its redistricting plan. Attached are the revised Trustee Area maps for the SCBE approved redistricting plan (Attachment 1). Once the Trustee Area maps have been adopted, narrative legal descriptions of each Trustee area will be prepared for approval.

The purpose of the public hearing currently before the Sacramento County Committee on School District Organization (County Committee) is to obtain public comment and to adopt a final redistricting plan for SCBE. Public notice of the hearing has been publicized in several places. Since July 18, 2011, the Sacramento County Office of Education (SCOE) website has contained a prominently displayed announcement of SCBE's approval of a redistricting plan, the date, time and location of this public hearing, and a link to the proposed new Trustee Area maps. On July 19, 2011, SCOE's communications office distributed a news release to 32 separate media contacts covering the Sacramento County region announcing the SCBE approved redistricting plan and this public hearing. A notice announcing this public hearing was published in the Sacramento Bee newspaper on July 24, 2011, and a news article about the hearing was published on August 1, 2011.

Once adopted by the County Committee, narrative legal descriptions will be prepared for each Trustee Area and submitted for approval. The final Trustee Area maps and V.A.1.

narrative descriptions will be submitted to the County Registrar of Voters in Sacramento, San Joaquin, Solano, Placer, and Yolo counties.

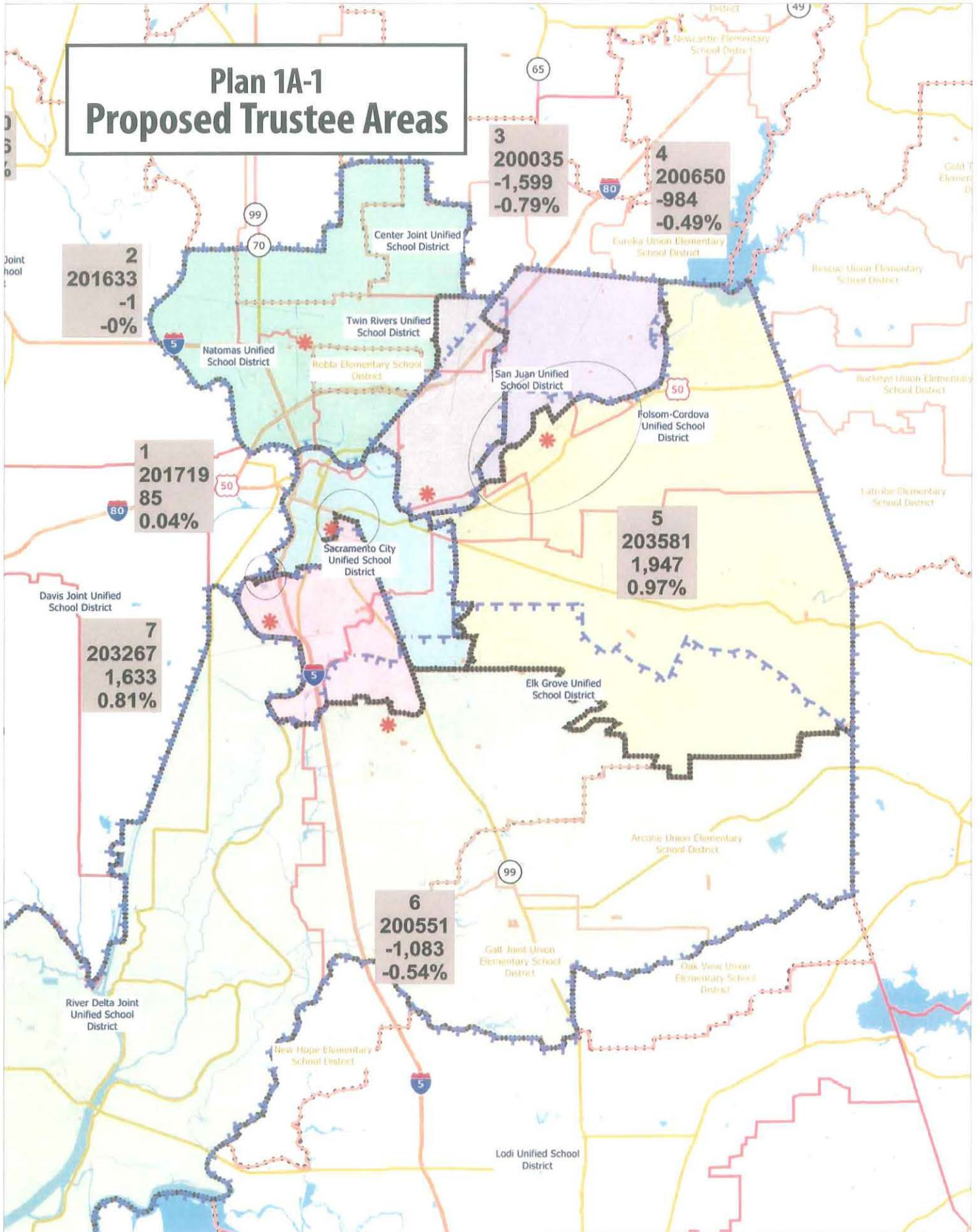
SACRAMENTO COUNTY BOARD OF EDUCATION'S RECOMMENDATION:

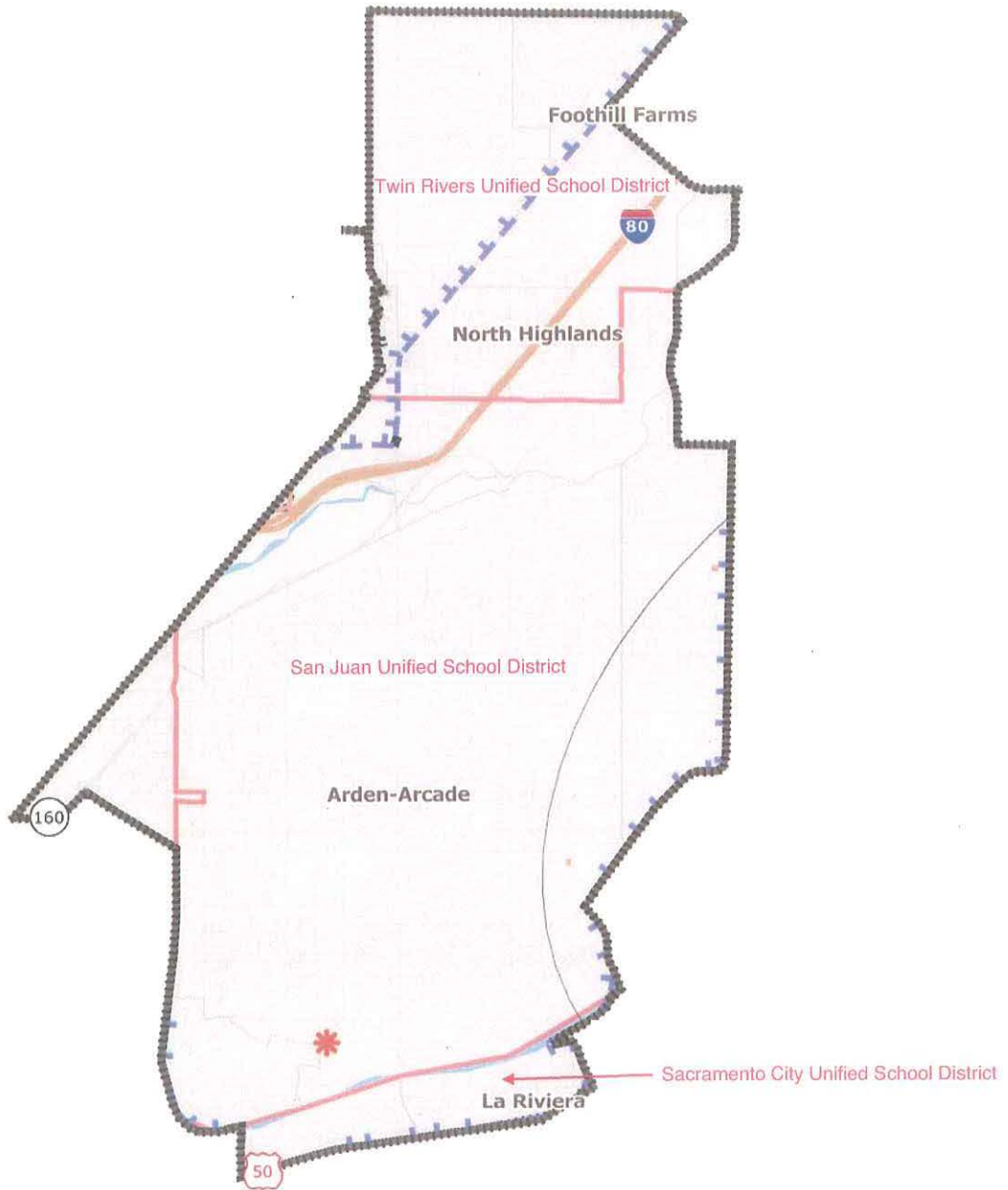

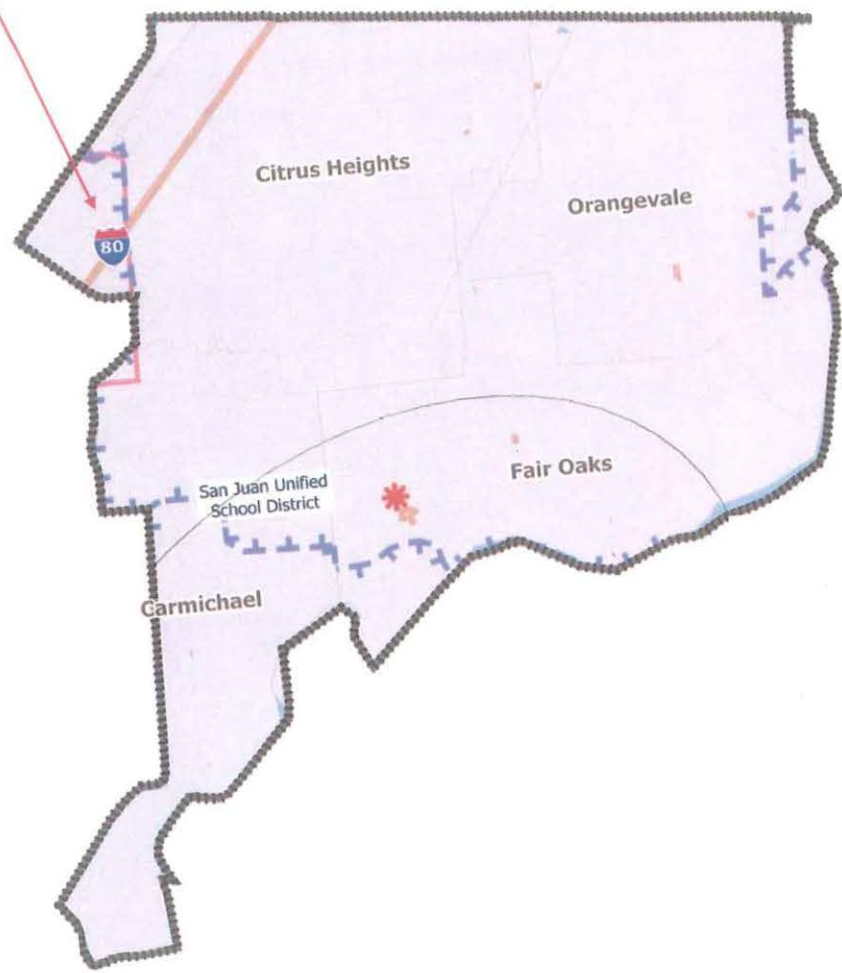

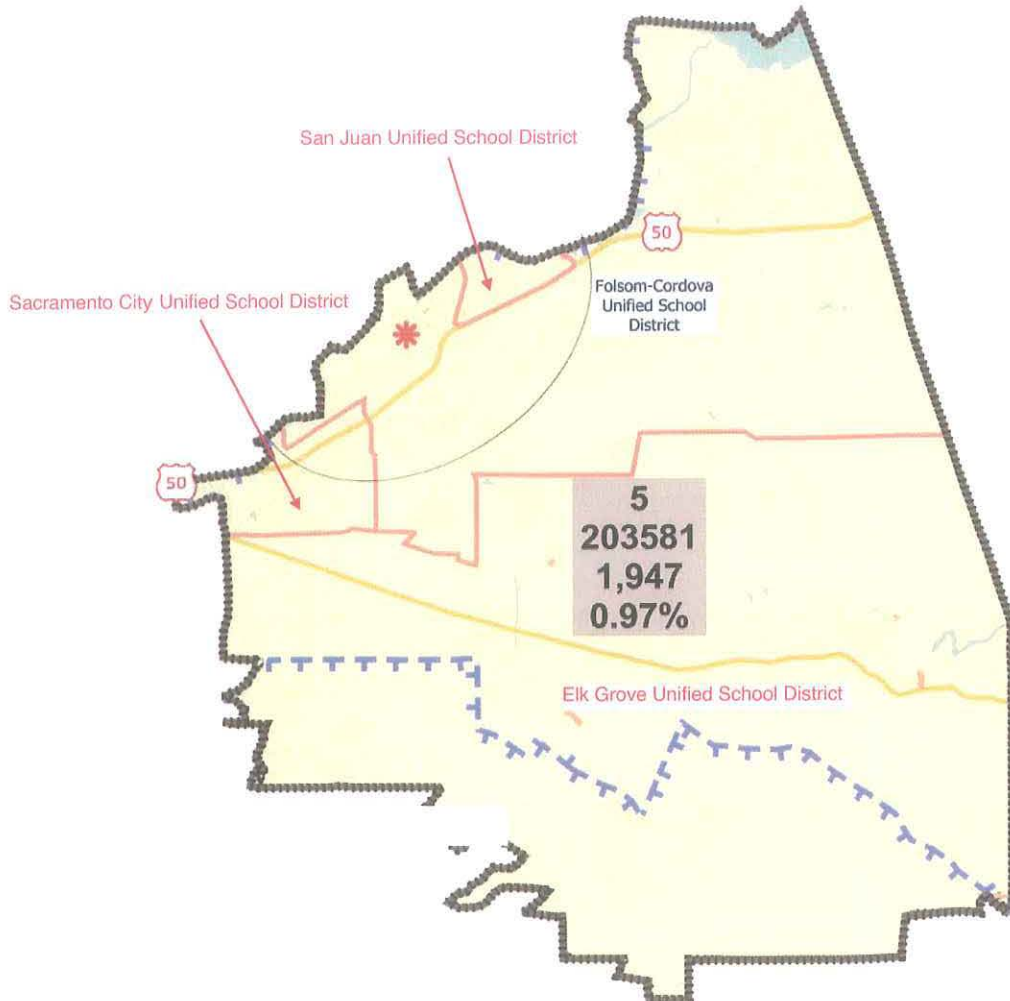

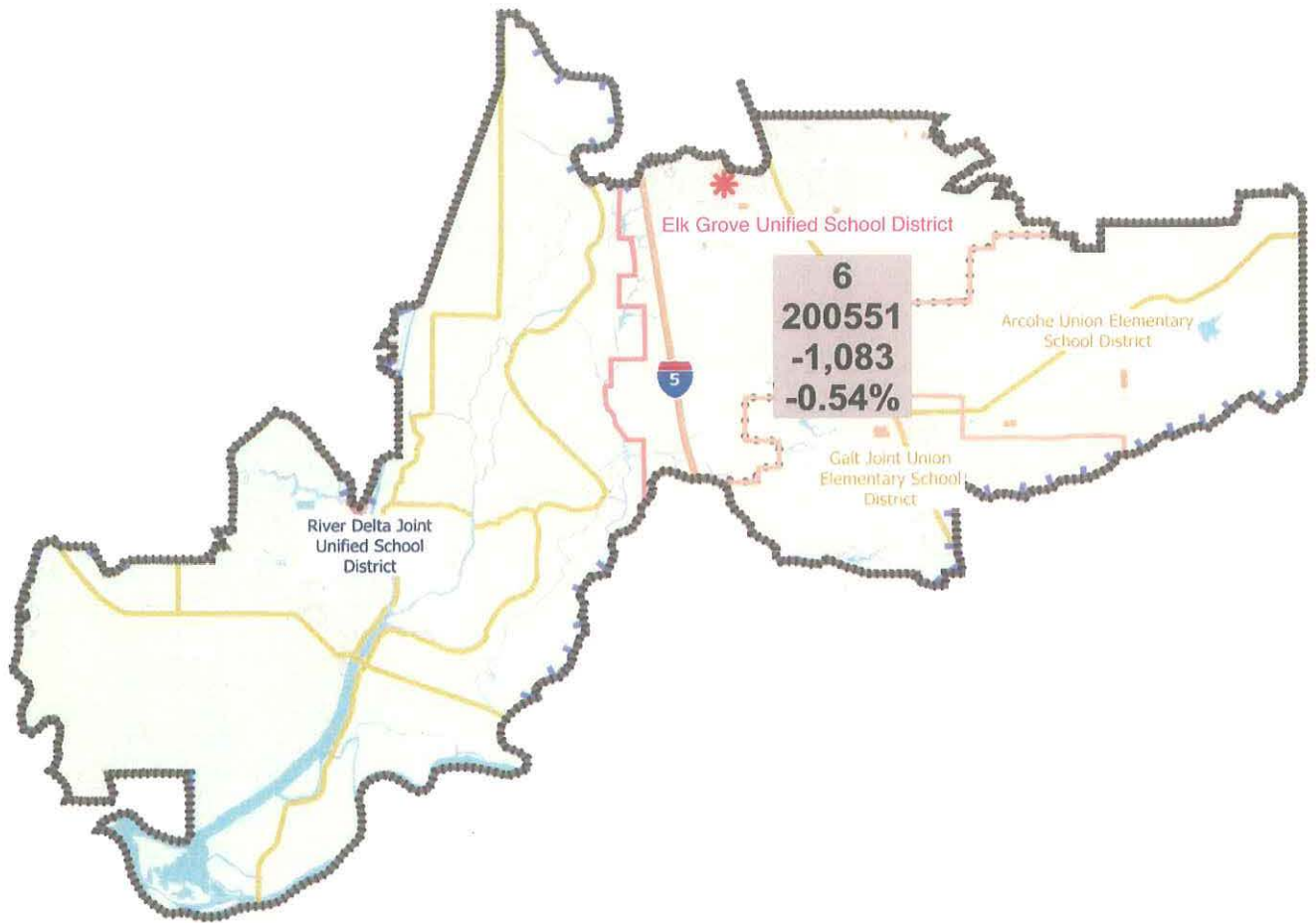

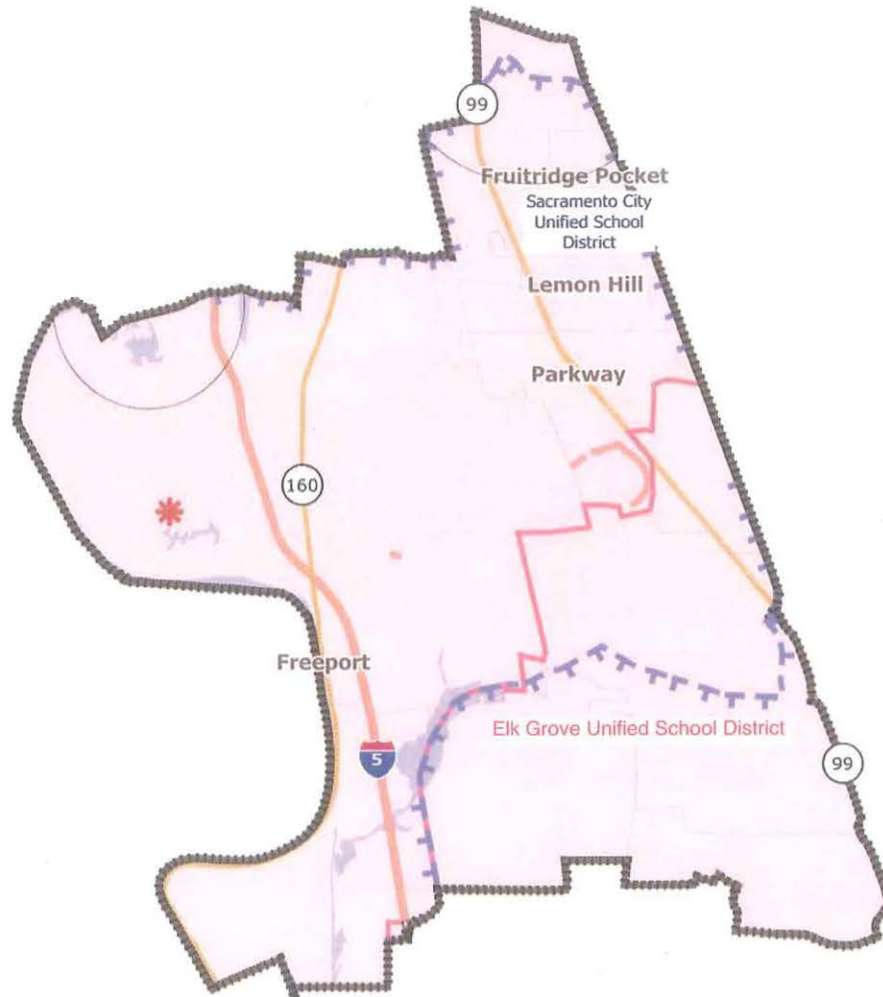

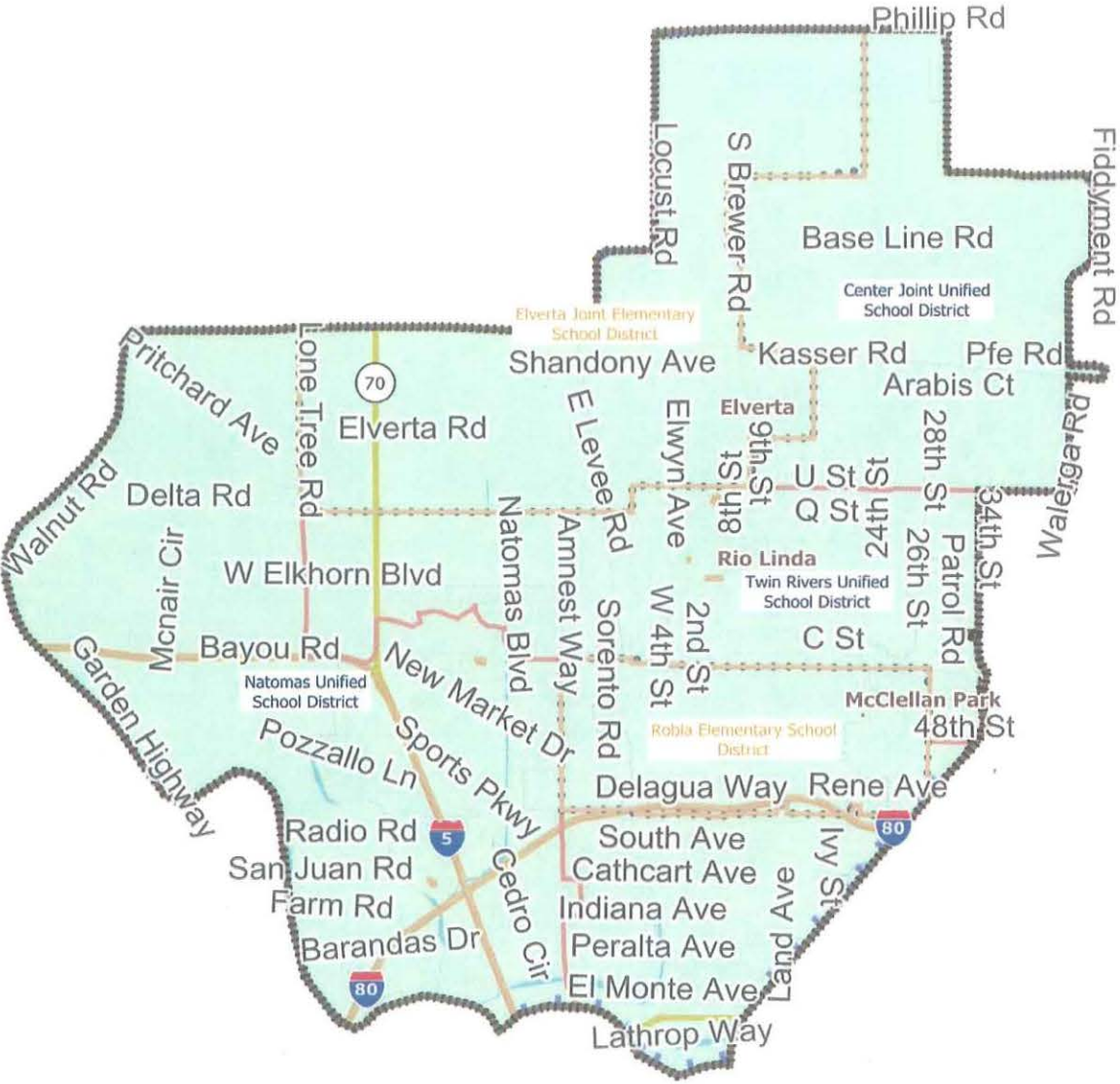


Proposed Trustee Area 2

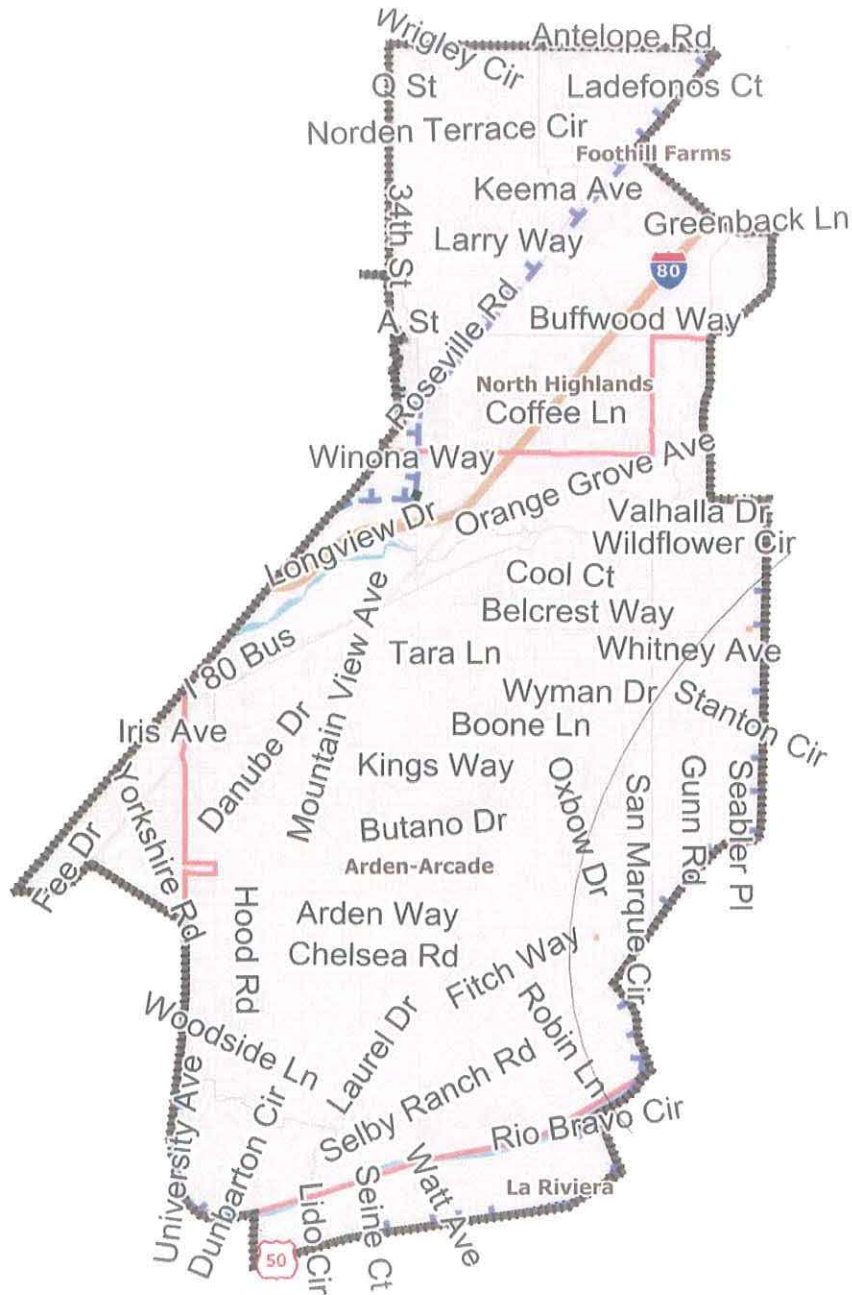


Proposed Trustee Area 3

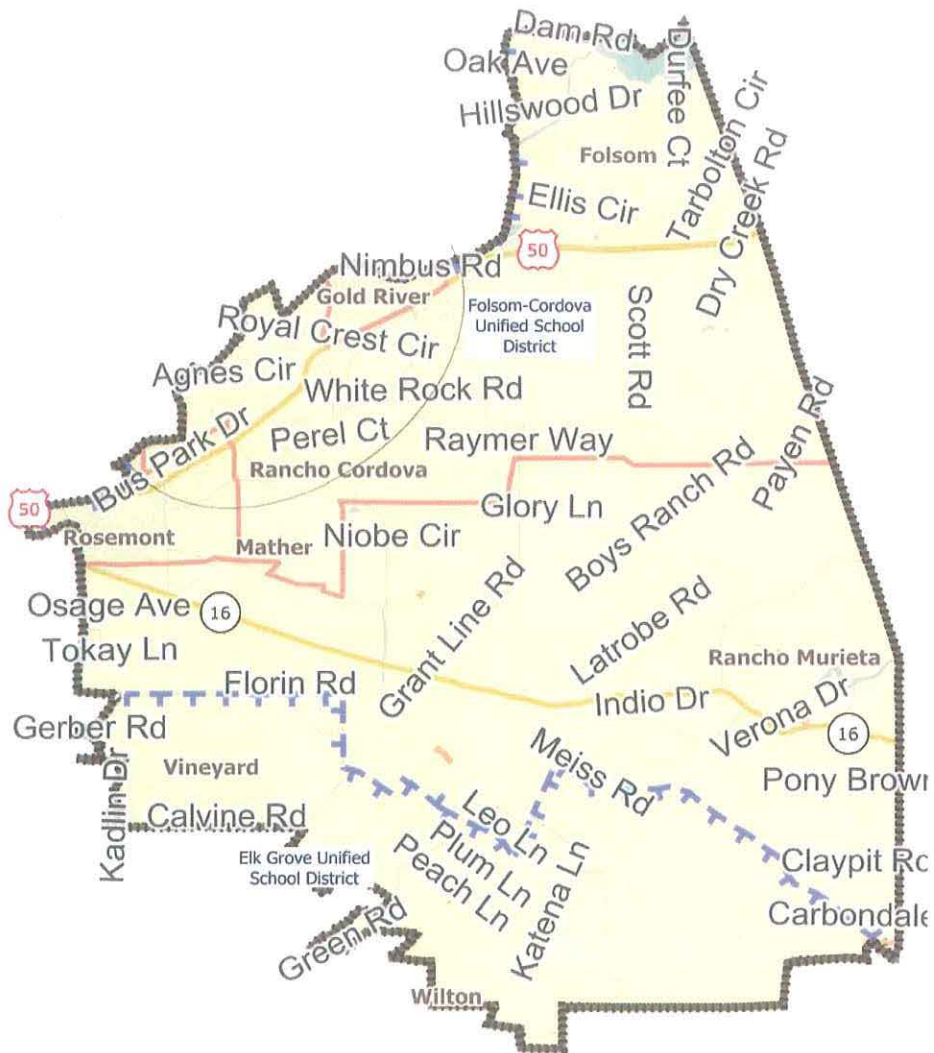


Proposed Trustee Area 5

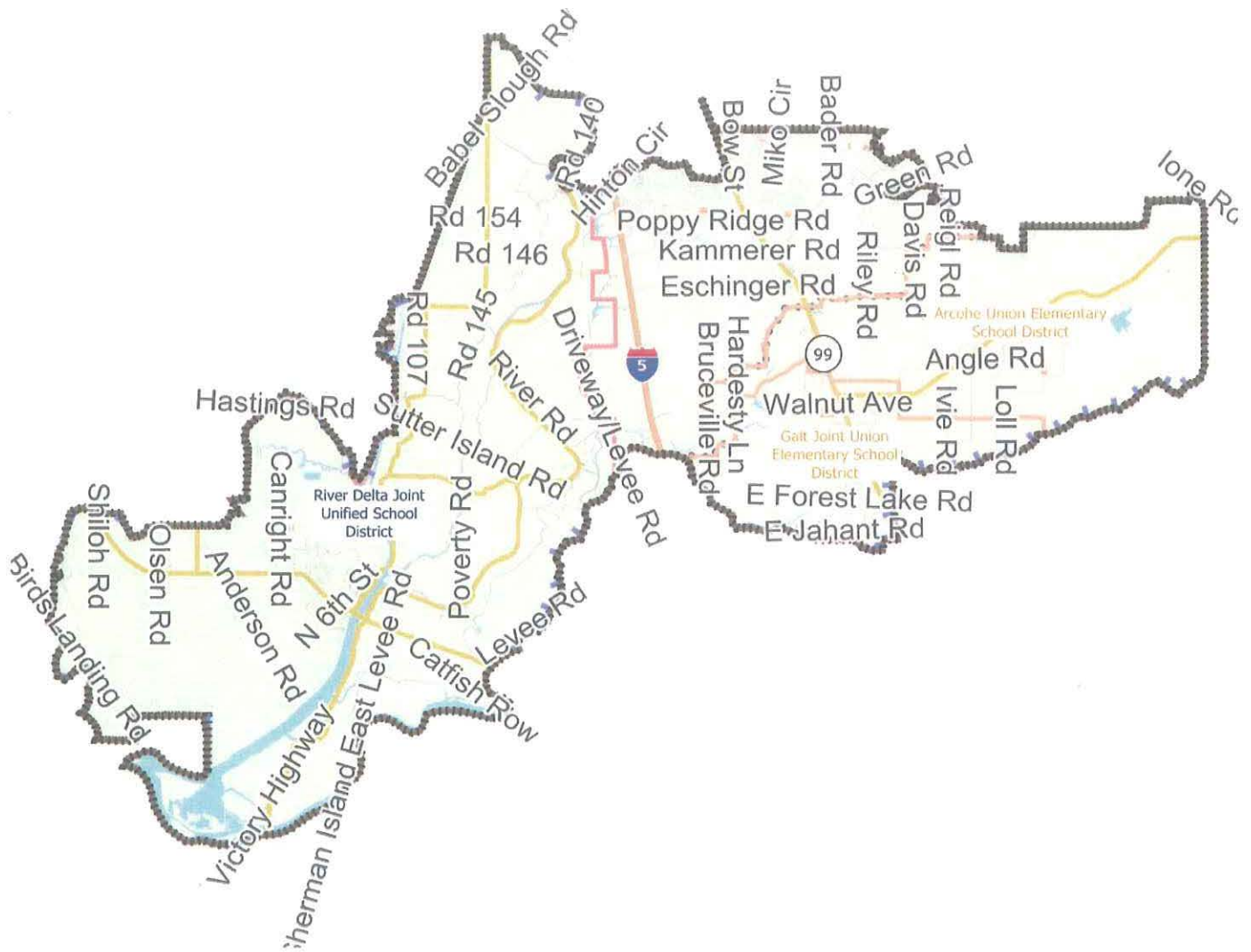


Proposed Trustee Area 6
