#### CONFLICT OF INTEREST CODE

The Political Reform Act (Government Code Section 81000, et seq.) requires state and local government agencies to adopt and promulgate conflict of interest codes. The Fair Political Practices Commission has adopted a regulation (2 California Code of Regulations Section 18730) that contains the terms of a standard conflict of interest code, which can be incorporated by reference in an agency's code. After public notice and hearing, the standard code may be amended by the Fair Political Practices Commission to conform to amendments in the Political Reform Act. Therefore, the terms of 2 California Code of Regulations Section 18730 and any amendments to it duly adopted by the Fair Political Practices Commission are hereby incorporated by reference. This regulation and the attached Appendices, designating officials and employees and establishing disclosure categories, shall constitute the conflict of interest code of the **Sacramento County Office of Education (SCOE).** 

Individuals holding designated positions shall file their statements of economic interests with the SCOE, which will make the statements available for public inspection and reproduction. (Gov. Code Sec. 81008.) All statements will be retained by the SCOE.

#### APPENDIX B – DISCLOSURE CATEGORIES

## Category 1

Designated positions assigned to this category must report investments, business positions in business entities, and income (including receipt of gifts, loans, and travel payments), from entities that provide leased facilities, products, equipment, goods, or services (including training or consulting services) of the type utilized by SCOE, as well as from entities for which SCOE provides oversight.

### Category 2

Designated positions assigned to this category must report investments, business positions in business entities, and income (including receipt of gifts, loans, and travel payments), from entities that provide leased facilities, products, equipment, goods, or services (including training or consulting services) of the type utilized by the designated position's department, as well as from entities for which the designated position's department provides oversight.

## Category 3

Interests in real property located in whole or in part within the boundaries of SCOE jurisdiction, or within two miles of the boundaries or of the jurisdiction, or within two miles of any land owned or used by SCOE.
