Resolution to Adopt Redistricting Plan for the Sacramento County Board of Education Trustee Areas Based on 2020 Census

Resolution No. CC-21-03

WHEREAS, pursuant to Education Code section 1002, subdivision (b), after each decennial federal census, county board of education trustee areas must be assessed and potentially adjusted in order to meet legally required population criteria.

WHEREAS, the Sacramento County Board of Education (Board) contracted with Cooperative Strategies, LLC (Demographer) for redistricting services and expertise.

WHEREAS, population data from the 2020 Census was analyzed and used to suggest potential adjustments to Trustee Areas in order to ensure compliance with state and federal law.

WHEREAS, at the Board's July 13, 2021 public meeting, the Demographer reviewed the standards and process for adjusting trustee area boundaries; and on October 19, 2021, November 16, 2021, and December 14, 2021, the Board, in its capacity as Sacramento County Committee on School District Organization (County Committee), conducted public hearings to review and consider potential trustee area adjustment scenarios and receive public input.

WHEREAS, Sacramento County Office of Education (SCOE) staff publicized the Board's trustee area redistricting process and solicited public comment on the Board's current trustee area boundaries and the alternative trustee area map scenarios through postings on SCOE's public website, social media postings, news releases sent to 23 different television and print media outlets throughout the region and the thirteen local school districts, a public notice published in the Sacramento Bee, and communications with SCOE's employee associations (California School Employees Association and Sacramento County Office of Education Teachers Association).

IT IS HEREBY RESOLVED that:

1. The recitals set forth above are true and correct.
2. The Sacramento County Committee on School District Organization hereby adopts the attached Trustee Areas map scenario No. 4 as the redistricting plan for the Sacramento County Board of Education Trustee Areas based upon the 2020 Census.
3. The attached final redistricting plan shall be submitted to the County Registrars of Voters in Sacramento, San Joaquin, Solano, Placer, and Yolo Counties for the June 7, 2022 Board election and subsequent elections.
4. The Sacramento County Committee on School District Organization hereby authorizes the Sacramento County Superintendent of Schools or designee to take any other actions needed to effectuate the purposes of this resolution.
