I. President Talamantes called the meeting to order at 6:32 p.m. via teleconference call in Sacramento, California. Board members present were Joanne Ahola, Alfred Brown, Heather Davis, Harold Fong, Paul Keefer, Bina Lefkovitz, and Karina Talamantes. Also present were David W. Gordon, Superintendent and Secretary to the Board; Nancy Herota, Deputy Superintendent; Teresa Stinson, General Counsel; Jerry Jones, Executive Director; Monica Eisel, Facilitator; other staff; and Wende Watson, Executive Assistant.

Other staff present via teleconference were Nicolas Schweizer, Associate Superintendent; Brent Malicote and Jacqueline White, Assistant Superintendents; Coleen Johnson, Chief Administrator; Michael Kast and Channa Cook-Harvey, Executive Directors; and Shanine Coats and Tim Herrera, Directors.

VII.A. Leslie Noriega, Transition Specialist, Elinor Lincoln Hickey Jr./Sr. High School, was recognized and honored as the classified employee of the month for October.

Sian Magee, Teacher, Alternative Education, CARE Program, was recognized and honored as the certificated employee of the month for October.

Superintendent Gordon reported on the following:

LOCAL DISTRICT UPDATES

- Arcohe: There has been low participation in independent study. The district is experiencing a shortage of subs.
- Center: COVID cases are slowing and processes for tracking are going well. Independent study enrollment has doubled. Retirees are coming back to assist with staffing shortage.
- Elk Grove: COVID cases are decreasing. District has increased rate for off-track teachers and retirees which has improved availability of staff.
- Elverta: Some staff are reluctant to be vaccinated.
- Folsom Cordova: Staff shortages and independent study issues creating stress. COVID cases are decreasing after a recent spike. There is a need for bus drivers, instructional assistants, and food service workers. Sub rates have been increased. Recently received a charter petition.
- Galt Elementary: Hired additional staff for contact tracing. Staffing for teachers and subs is adequate. Need classified staff. The number of students quarantined has decreased.
- Galt High: COVID cases are decreasing. 39 students enrolled in independent study. Reaching out to retirees for staffing support.
- River Delta: Hired health assistants to support contact tracing.
- Robla: Contact tracing is a challenge. Staff shortages in Special Ed and subs.
- Sacramento City: 162 active quarantine cases thus far. Staff shortages are a problem. Passed a proposal to increase sub rates.
- San Juan: COVID cases are decreasing.

COMMUNITY SCHOOLS

- We have 19 students enrolled at Colley and 17 enrolled at Hickey.
- We are excited to report that our Community Based Organizations (CBOs) have returned to providing services including Earth Mama Healing (mentoring), The Hawk Institute (Mentoring), Milton Bowens (visual artist in residence), and 916 Ink (writing). We expect to welcome additional CBOs this year.

SENIOR EXTENSION

 We are currently serving students at five locations and have over 328 students enrolled to date. Our Senior Extension Programs have expanded access to RSP services. Our Community Based Organizations are providing supports to Senior Extension.

EL CENTRO

- Improving Your Tomorrow (IYT) has started working with students in the El Centro Program. This work is part of a pilot project to engage students with mentoring services while attending El Centro and provide continuing services when they transition to other school settings.
- Milton Bowens (visual artist) has begun his yearlong residency with the girl's unit.

SPECIAL EDUCATION UPDATE

- Special Education will be collapsing and consolidating classrooms to better utilize staff and best accommodate students as we teach our students through in-person and Independent Study.
 - Seven classes in total that had low enrollment were combined into three in-person classrooms.
- These new combined classes started Monday, September 13.
- The other four teachers not teaching in-person will teach independent study classes for up to 48 students.
- This allowed us to put appropriate staffing in all of our classrooms.
 Before this change we had over five paraprofessional vacancies that we were unable to fill.
- All in-person classes are going well. We have had to quarantine several students, but we are following all public health protocols and students and staff are returning to in-person after their quarantine period.

SUMMER INNOVATION HUBS

 During the months of June and July, 175 students were served in SCOE's Summer Education Innovation Centers at three school sites: FC Joyce in Twin Rivers Unified, Rosa Parks in Sacramento City Unified, and Thomas Edison in San Juan Unified. The Summer Centers were created to support our Sacramento Communities and to create safe, welcoming spaces for students, SCOE partnered with Community-Based Organizations, local non-profits, and school districts. The video that we created showcases highlights of the program.

SCHOOLSFIRST BACKPACK DONATIONS

 Thanks to a generous donation of backpacks filled with school supplies, courtesy of SchoolsFirst Federal Credit Union, 100 children in Sacramento County will be better prepared for school this year. Our Project TEACH homeless services program received the backpacks – filled with supplies – on September 1. Many thanks to our friends from SchoolsFirst.

HONOR OUR EDUCATORS - SAC REPUBLIC FC

 On August 28, the 2021 Sacramento County Classified School Employees of the Year and the County Teachers of the Year 2022 were recognized during halftime at the Sacramento Republic FC game against San Diego, at Heart Health Park. The team paid tribute to both groups of school employees at "Honor Our Educators Night." His thanks to Board President Talamantes who joined the honorees as they were introduced to the cheering crowd and presented with awards.

CA KIDS FIRE RELIEF

- On August 25, he took part in a news conference to announce the launch of "CA Kids Fire Relief." This is a statewide effort where students and school communities are being urged to provide financial and emotional support to students, families, and schools impacted by the catastrophic wildfires.
- Tim Taylor from the Small School Districts Association and El Dorado County Superintendent Ed Manansala, and Nevada County Superintendent Scott Lay joined this event.
- During this effort, we are asking for donations of gift cards for food, clothing, gasoline, and credit card-style gift cards.
- SCOE is the collection point. The cards which will be distributed to the affected schools, students, and families.
- On September 9, leaders of our organizations CSEA and SCOETA made generous donations to the program.
- Many thanks to SCOETA President John Liddicoat and CSEA 1st Vice President Tara Degg who made the donations on behalf of their organizations.

SENATE HEARING TESTIMONY

- On August 18, he testified virtually for the Senate Special Committee on Pandemic Emergency Response and Senate Education Committee.
- He talked about the work of the Mental Health Services Oversight and Accountability Commission – or MHSOAC – on which he serves.
- He also spoke about the importance of youth voice in meeting the mental health needs of our children, and about SCOE's work in making schools Centers of Wellness in Sacramento County.
- He also spoke of how we are coordinating \$6.8 million from FEMA and DHCS to facilitate a statewide Social Emotional Learning Community of Practice that started in January 2021 and will continue for the next three years.

IMPROVE YOUR TOMORROW

- SCOE partners with many great nonprofits to support our students.
 And one of those valued partners Improve Your Tomorrow or IYT chose SCOE as the site to announce some exciting news.
- IYT's mission is to increase the number of young men of color to attend and graduate from colleges and universities. They work closely with our students.

- On August 16, IYT announced the receipt of a \$1.6 million state grant to continue their work.
- The funding will allow them to train and hire more mentors to support young people. The group used the SCOE Conference Center to conduct mentor training after making their announcement.

Matt joined SCOE in July of 2012 and did a remarkable job throughout his time here. We had a very nice sendoff for Matt last week. A final note: Matt had requested no retirement gifts but asked that people contribute to the SCOE Resiliency Scholarship Fund on his behalf.
