I. President Brown called the meeting to order at 6:32 p.m. in the Board Room of the David P. Meaney Education Center, Sacramento County Office of Education, 10474 Mather Boulevard, Mather, California. Board members present were Joanne Ahola, Alfred Brown, Heather Davis, Harold Fong, Paul Keefer, Bina Lefkovitz, and Karina Talamantes. Also present were David W. Gordon, Superintendent and Secretary to the Board; Al Rogers, Deputy Superintendent; Teresa Stinson, General Counsel; Nancy Herota, Matt Perry, and Tammy Sanchez, Assistant Superintendents; Coleen Johnson, Chief Administrator-Human Resources; Michael Kast, Executive Director of Special Education; Jerry Jones, Executive Director of Technology; Tim Herrera, Director of Communications; other staff and visitors; and Carla Miller, Recording Secretary.

II. Ms. Talamantes led the Pledge of Allegiance.

III. On a motion by Mr. Fong and seconded by Ms. Davis, the revised minutes of the Regular Board Meeting of January 15, 2019 were approved. Motion carried 6 ayes, 1 abstention (Ahola).

IV. Ms. Ahola moved to adopt the agenda. Ms. Lefkovitz seconded the motion, which carried unanimously (7 ayes).

- V. There was no official correspondence.
- VI.A. There were no requests for visitor presentations from the general public.
- VI.B. There were no requests for presentations from employee organizations.
- VII. Superintendent Gordon reported on the following:
 - Congratulated Bella Vista High School for winning the 2019 Sacramento County Academic Decathlon. The event was Saturday at Folsom High School and the awards dinner was last night. Folsom High School finished second, followed by Pleasant Grove High School in third place. Many thanks to President Brown and Trustee Lefkovitz for attending the Super Quiz. And thanks to President Brown for attending last night's awards dinner. Bella Vista High School will represent Sacramento County in the California Academic Decathlon in Sacramento, March 22-23, 2019. He thanked our sponsor SAFE Credit Union for once again providing \$10,000 in college scholarships for the top performing students. We invited Butte County high schools to join the competition, in addition to three Placer County high schools. During a break in the Super Quiz, we

had a nice moment when Butte County teachers received school supplies donated by Sacramento County educators. He recognized Tim Herrera and Craig Irish for organizing both outstanding events.

- Reminded everyone that tomorrow, February 6, we are hosting our Sacramento County School Boards Association dinner meeting at 6:00 p.m. in the Mather Room. Our guest speaker will be Kevin Gordon, President and Partner of Capitol Advisors Group, LLC. His topic: Everyone in Sacramento Is New – Where Do We Go from Here?

- Finally, he brought attention to the Board regarding two articles for them to have. The first article on preserving our democracy is written by Bill Honig, former State Superintendent of Public Instruction. The second article is written by New York Times columnist David Brooks and it deals with the importance of strong student/teacher relationships. We shared these articles with our SCOE Leadership Team during our January meeting.

VIII.A. Mr. Keefer moved and Mr. Fong seconded the adoption of the consent agenda. Motion carried unanimously (7 ayes). By such action, the Board:

VIII.B. No Approval of Contracts

VIII.C. On a motion by Ms. Lefkovitz, seconded by Ms. Talamantes, and carried unanimously (7 ayes), the Board authorized staff to submit grant applications/service contracts and accept funding if awarded; and approved contracts, positions, and other expenditures associated with the grants as outlined in the proposed budgets as follows:

- \$750,000 Prevention Coalition Alcohol and Substance Abuse Prevention (ASAP 2.0) grant from Sacramento County Behavioral Health Services, Alcohol and Drug Services for the 2018-2019 and 2019-2020 fiscal years

VIII.D. President Brown stated that Item D. involves a request on his behalf and therefore, he would like to ask Vice President Ahola to handle this item. He will be abstaining.

Ms. Davis moved and Ms. Lefkovitz seconded the motion to approve authorization for Out of State Travel for Trustee Brown to attend the 49th Annual Capitol-to-Capitol Conference in Washington, DC. Motion carried 6 ayes, 1 abstention (Brown).

Mr. Fong requested a report from President Brown when he returns.

VIII.E. Mr. Fong moved and Mr. Keefer seconded the motion to award contracts if SCOE receives E-Rate Discounts for Fiscal Year 2018-2019. Motion carried unanimously (7 ayes).

VIII.F. Ms. Lefkovitz moved and Ms. Talamantes seconded the motion to approve Diana Batista as SCOE's designated member representative to the Capital Adult Education Regional Consortium (CAERC). Motion carried unanimously (7 ayes).

VIII.G. President Brown announced this was the Second Reading and Adoption of Revisions to Board Policy 5113.2 (Renumbered 5113) – Pupil Attendance and Truancy.

Chair Joanne Ahola of the Policy Committee recommended the Board adopt revisions to Board Policy 5113.2 (Renumbered 5113) – Pupil Attendance and Truancy, as amended. Motion carried unanimously (7 ayes).

To address Mr. Fong's request to address student challenges related to homelessness, "homeless liaisons" will be added to the last paragraph on page VIII.G.2. as an additional collaborative partner for addressing pupils' needs.

VIII.H. An informational item on Revisions to Administrative Rules and Regulations – 5113.2 (Renumbered 5113) – Pupil Attendance and Truancy was provided in the Board packet.

Per Mr. Fong's request "homeless liaisons" will be added to the ARR as well. See Item VIII.G.

VIII.I. Tammy Sanchez, Assistant Superintendent, provided a report on the Governor's Budget to the Board.

IX.A. Mr. Fong stated that last month we all said Happy New Year to everybody. Now that we're in February, Happy Chinese New Year.

Mr. Keefer wished a Happy New Year to Trustee Fong and everyone else. Last week, he attended the California Community College's town hall and college fair. Trustee Lefkovitz was in attendance as well. He sat in on a session with students and was impressed how they described the difficulties faced by students in multiple areas. It really demonstrates how Sacramento County Office of Education is such a great place to support K-12 students. During his free time, he is very focused on incorporating change within his Area III. He thanked the staff and Superintendent Gordon for hearing his concerns and guiding him through the process. Now that he is seven months into this role, he realizes this is a marathon, not a sprint. The Board is working with SCOE staff in different ways. The fact that we have great consensus on so many topics is fantastic. He offered support to fellow trustees to make any type of changes in their areas. He may be calling on them for efforts that he is trying to achieve in his area.

Ms. Davis – no report.

Ms. Talamantes said the CSBA conference reminded her that this role is not a sprint; it's a marathon. She attended a Digital Inclusion Summit two weeks ago. When she saw that SCOE was presenting on two different topics, she got excited to learn more about what SCOE does. Digital equity is very important. If we want to make sure our kids have the resources, we need to work with other stakeholders in the city and the county to make sure families have access to Internet and computers for homework. She would like a presentation on it in the near future. Happy New Year Trustee Fong.

Ms. Lefkovitz wished Trustee Fong a Happy New Year. She stated that she felt bad that this is a significant holiday in his culture and that we are meeting. If it is considered a significant holiday, it might be good to keep that in mind when we are scheduling Board meetings in the future. She asked if the 5% lowest preforming schools list is out yet, and if it has, can the Board members get a copy of which of our schools are on that list.

Superintendent Gordon said that the list just came out. It is up to the districts to ask for money for their qualifying schools. As soon as he knows what the districts want, he will provide a list.

Ms. Lefkovitz stated there is an expectation that the Stephon Clark ruling will be coming out in the next week or so. She does not know how it will impact our students and schools. She knows there are a lot of people gearing up to make sure that we give people an opportunity to express their feelings and to make sure we are safe. She hopes we are prepared. She believes it is important to provide space for our students to talk about it and understand and take peaceful action.

Ms. Ahola – no report. Listening to each of you share your reports makes her very proud to serve alongside the Board.

IX.B. President Brown stated he agreed with what everyone has said so far. He was working on a project, Sunrise Elementary School garden. He assisted with connecting the school to Lowe's, whose manager agreed to provide supplies to help build a garden. When the school has the groundbreaking, he would like everybody to be there. The Academic Decathlon was outstanding. Please don't miss it next year. Craig Irish and Tim Herrera did an outstanding job. The kids were excited.

Mr. Wilson provides instruction and opportunities in landscaping and horticulture, coordinates community service projects, and serves as a liaison involving special ventures for Adult Re-Entry programs in Placer, Sacramento, and Yolo Counties. All sites combined can serve up to 650 clients at a time, and he is committed to ensuring every client has an opportunity to learn. Helped by re-entry volunteers, Mr. Wilson partners with community agencies to complete projects that improve public areas. Clients benefit long-term from participating in these projects by learning how to work with others in real-life scenarios. Ultimately, this translates to employable skills, which are part of successful re-entry. Mr. Wilson has been a Sacramento County Office of Education employee since July 2007.

CERTIFICATED

Eliane Perrone, Adult Re-Entry Program Transition Specialist, was nominated by Sacramento Community Based Coalition Director Marc Nigel for her contributions to SCOE. Ms. Perrone is a Transition Specialist at the Placer Re-Entry Program, where she has a high outcome rate for graduates and helps clients transition into their communities. She helped establish procedures to support program efficiency for clients obtaining Medi-Cal, GED, or high school diploma. Recently, she filled a void by providing supplemental services to clients in Kings Beach, Lake Tahoe. Without hesitation, she volunteered to meet this need and established services for this underserved community. Ms. Perrone has been employed by the Sacramento County Office of Education since July 2015.

BACKGROUND:

Education Code sections 17545 and 17546 allow for the disposal of property no longer needed or that is determined unsuitable for school use.

The technology equipment listed below has been determined to be unsuitable for use and of insufficient value to defray the costs of arranging a sale. It is in the Sacramento County of Education's best interest to deem these items obsolete and dispose of them. All storage devices (hard drives, solid state drives, USB drives, etc.) are completely wiped of data and, whenever possible, physically shredded to ensure the destruction of all electronic data before disposal.
