The following proposal uses the interest-based format designed to address interests and not specific solutions. If the negotiation teams find alternate ways to address the same interest in a different article, it is opened and available for the partners to review through the interest-based process.

Our general interests include:

- 1. Continuing a positive, productive working relationship with our bargaining partners.
- 2. Recruiting and retaining qualified classified staff.
- 3. Working collaboratively to respond to emergencies, including pandemics.

The Classified School Employees' Association, Chapter 480 (CSEA) has an interest in negotiating the following topics pertaining to the CSEA contract:

- 1. Article XII Pay and Allowances CSEA proposes language which would expand the rights of bargaining unit members regarding changes to work.
- Article XIV Health and Welfare Benefits CSEA hereby proposes language which would provide increased flexibility in the use of bargaining unit members' contributions into the adverse selection fund.
- 3. Article XV Holidays CSEA hereby proposed language which would protect bargaining until members' pay during periods of closure.

The Sacramento County Office of Education has an interest in negotiating the following topics pertaining to the CSEA contract:

- 1. Article XII Pay and Allowances SCOE proposes language which would align the issuance of December payroll with the County Treasury.
- Article XII Pay and Allowances SCOE proposes language which would update
 the date of payment of the Educational stipend to align with CalPERS'
 reportability.
