Meaney Education Center, Sacramento County Office of Education, 10474 Mather Boulevard, Mather, California. Board members present were Joanne Ahola, Alfred Brown, Heather Davis, Harold Fong, Paul Keefer, Bina Lefkovitz, and Karina Talamantes. Also present were David W. Gordon, Superintendent and Secretary to the Board; Al Rogers, Deputy Superintendent; Teresa Stinson, General Counsel; Tammy Sanchez, Associate Superintendent; Nancy Herota, Assistant Superintendent; Coleen Johnson, Chief Administrator-Human Resources; Michael Kast, Executive Director of Special Education; Jerry Jones, Executive Director of Technology; Tim Herrera, Director of Communications; Rachel Perry, Director of C-SAPA; other staff and visitors; and Carla Miller, Superintendent/Board Liaison.

- IV. Ms. Lefkovitz moved to adopt the agenda. Mr. Fong seconded the motion, which carried unanimously (7 ayes).

- VI.A. There were no requests for visitor presentations from the general public.

- VII.A. Superintendent Gordon reported on the following:

- Please join us tomorrow March 20 when we host an Open House at our Leo A. Palmiter Jr./Sr. High School campus. Culinary Instructor Chef Steve Hazelton is preparing a nice meal. The evening begins at 5:30 p.m.
- Congratulated Scott Burton. Last month, he was named SCOE's Classified Employee of the Year for 2019. Now he has been selected Sacramento County's Classified Employee of the Year in the Maintenance, Operations, and Facilities category. Scott is a Senior General Services Worker in the Support Services Department. AND, Kerstin Morell, a Family Advocate in our Help Me Grow program, was selected as Sacramento County's Classified Employee of the Year in the Support Services and Security category. Congratulations to Scott and Kerstin. They now both move on to the State level of this CDE recognition program.

- On March 2, over 300 students participated in Sacramento County History Day, which was held at Inderkum High School. "Triumph & Tragedy in History" is the 2019 theme. Students earning honors in Sacramento advanced to the National History Day California competition, scheduled for May 11-12 at William Jessup University, in Rocklin. Thanks to Craig Irish for another great History Day event, as well as Mock Trial and Moot Court.
- State Superintendent Tony Thurmond announced the list of middle and high schools being honored under the 2019 Distinguished Schools Program. Four Sacramento County Schools have been recognized: ① Pleasant Grove High School in Elk Grove, ② Natomas Pacific Pathways Prep in Natomas, ③ West Campus and ④ School of Engineering and Science in Sac City Unified. Schools are awarded for achieving exceptional student performance for two consecutive school years or closing the achievement gap between two school years.

VIII.D. Pending Charter School Legislation (Assembly Bills 1505-1508)

Superintendent Gordon added the Governor has appointed a task force to consider charter issues, these Assembly Bills 1505-1508, being among the topics. He distributed the task force member list.

A potential Resolution opposing AB 1505 was distributed to Board members. Board members discussed AB 1505-1508, and whether to take action on a Resolution at a future Board meeting.

Mr. Keefer moved and Ms. Ahola seconded the motion to place the resolution regarding AB 1505 on the agenda for a special meeting to be held on March 26, 2019.

Additionally, she visited SCBC – Adult Re-Entry – with Marc Nigel, Natalya Edwards, Dr. Matt Perry, and their team. Both visits were outstanding.

Ms. Talamantes departed the meeting early and therefore was not present at this time.

Ms. Lefkovitz and President Brown attended a workshop by CSBA. She has the guidebook if anyone would like to take a look at it. One presentation that stood out to her, talked about board and superintendent roles and responsibilities. She feels that we have a good partnership with our superintendent.

Cline Moore, Behavioral Management Technician, was nominated by Principal Lauren Roth for his contributions to the Special Education Program of the Sacramento County Office of Education. Cline Moore works at the Leo A. Palmiter Jr./Sr. High School campus. He participates in the Positive Behavior Interventions and Supports (PBIS) Leadership team which emphasizes teaching students' school-wide expectations and acknowledging them for work well done. Mr. Moore serves as a mentor with Check In, Check Out, the school mentoring program. He has been integral in developing a positive climate and culture on the campus. Mr. Moore leads Friday Night Live activities such as neighborhood graffiti abatement and town hall meetings with students and their families. He developed the Bike Club at Palmiter, where students paint and repair bicycles that have been donated by the Sheriff's Department, which they then get to keep. Mr. Moore has been employed by SCOE since July 2013.

<u>CERTIFICATED</u>

Nick Papagiannopoulos, ED Teacher, was nominated by Principal Lauren Roth for his contributions to the Sacramento County Office of Education. Known as "Mr. Pappas" to his students, he teaches the 12th grade Transition Partnership Program (TPP) Class at SCOE's Leo A. Palmiter Jr./Sr. High School. He has served as Teacher in Charge, and leads the Chick-Fil-A Leadership Academy and Student Council. Mr. Papagiannopoulos also takes the lead with curriculum adoption and implementation. Students enrolled in this class, which is coordinated in partnership with the California Department of Rehabilitation, are working on meeting goals that lead to employment. When working with students, he is encouraging and able to provide life lessons to help students transition smoothly from high school to post-secondary activities. Mr. Papagiannopoulos has been employed by SCOE since August 2013.
