Compact and contiguous, as much as possible

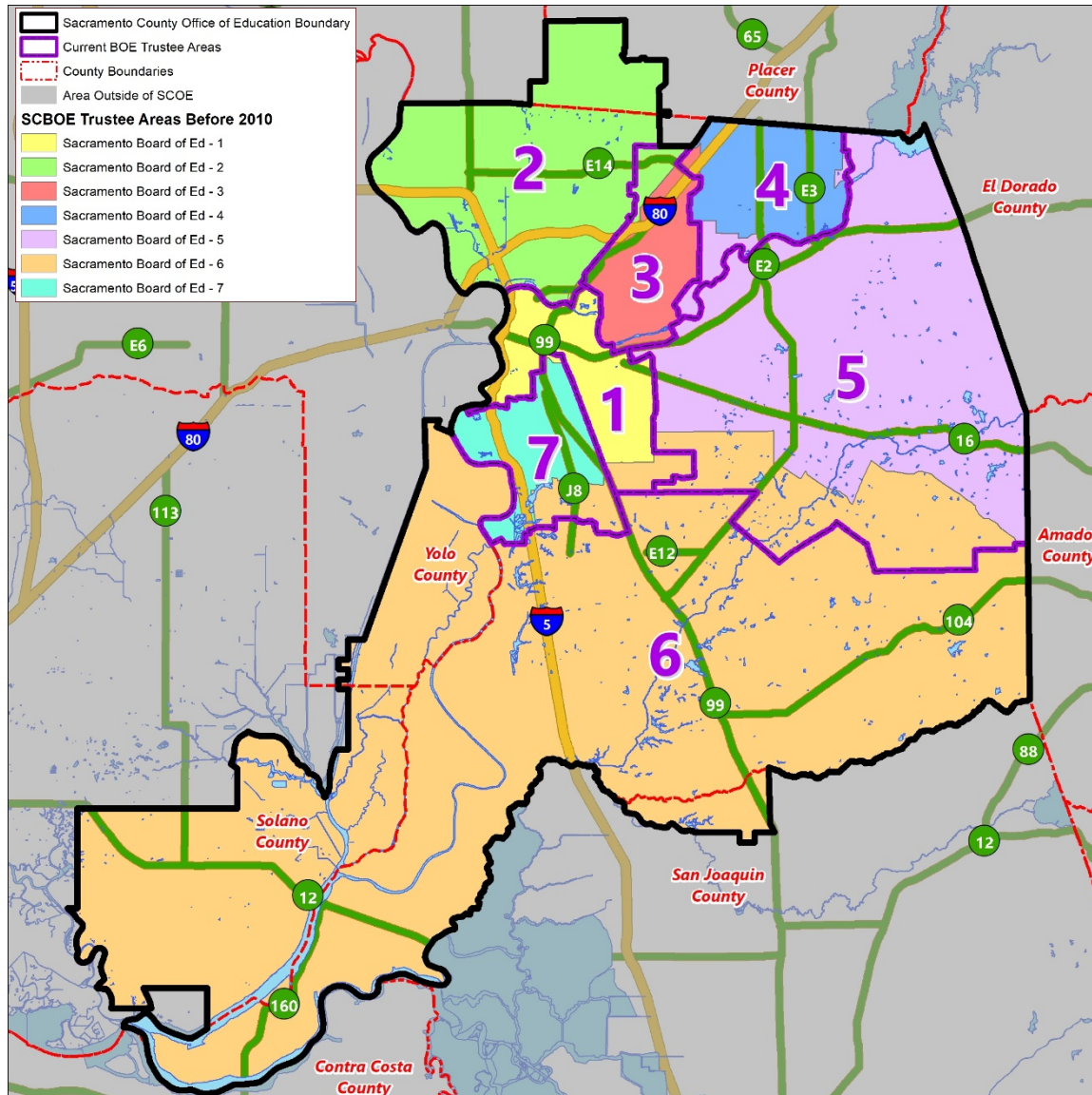

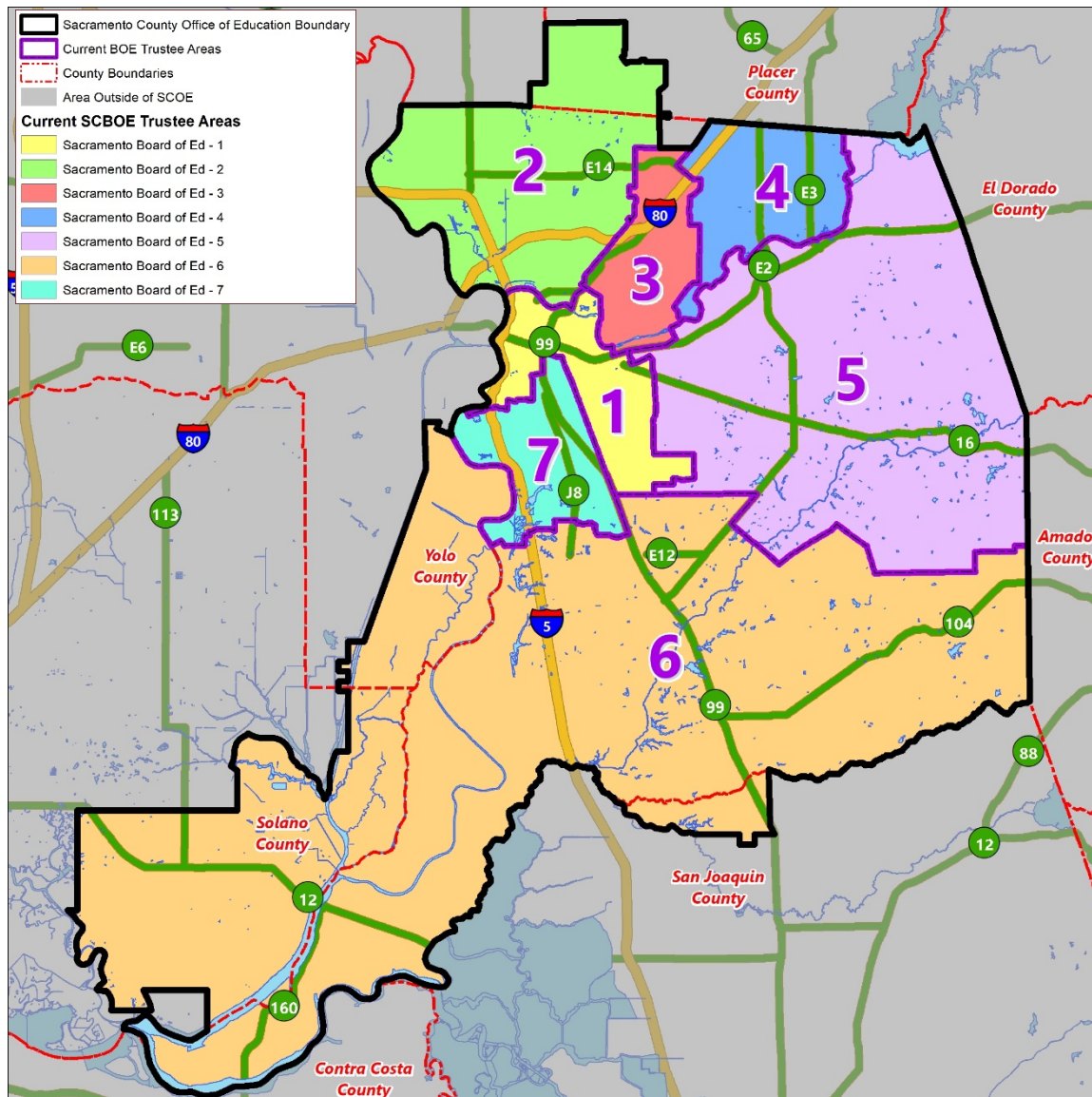

- Colors show 2000 TA boundaries; Purple lines show boundaries after 2010 redistricting.
- Between 2000 – 2010, significant population growth in north and south, with less growth in central areas.
- Challenge to move populations from growing north and south regions into central areas of SCBE to balance population

- Variance between most populated and least populated TAs reduced from 52.1% to 1.8%
- Areas 2 (Natomas) and 6 (Elk Grove) reduced to account for exponential population growth between 2000 and 2010 Census
- Central urban TAs (1 & 7) expanded to include similar communities/neighborhoods in Sacramento
- Aligned TAs with school district boundaries where possible, natural boundaries also used (i.e., Am. River)

► SCBE DEMOGRAPHICS
2020 CENSUS DATA



- Final validated redistricting data was released by the California Department of Finance on September 27, 2021.
- Notable changes in the area served by the Sacramento County Board of Education ("SCBOE") from 2010 to 2020, include:
 - Overall population growth of over 166,000 (11.8%);
 - Changes in the demographic composition, most notably, increases in the proportional share of Hispanic/Latino and Asian populations.
- These changes represent an 8.3% population variance among SCBOE trustee areas, which is within the 10% threshold.

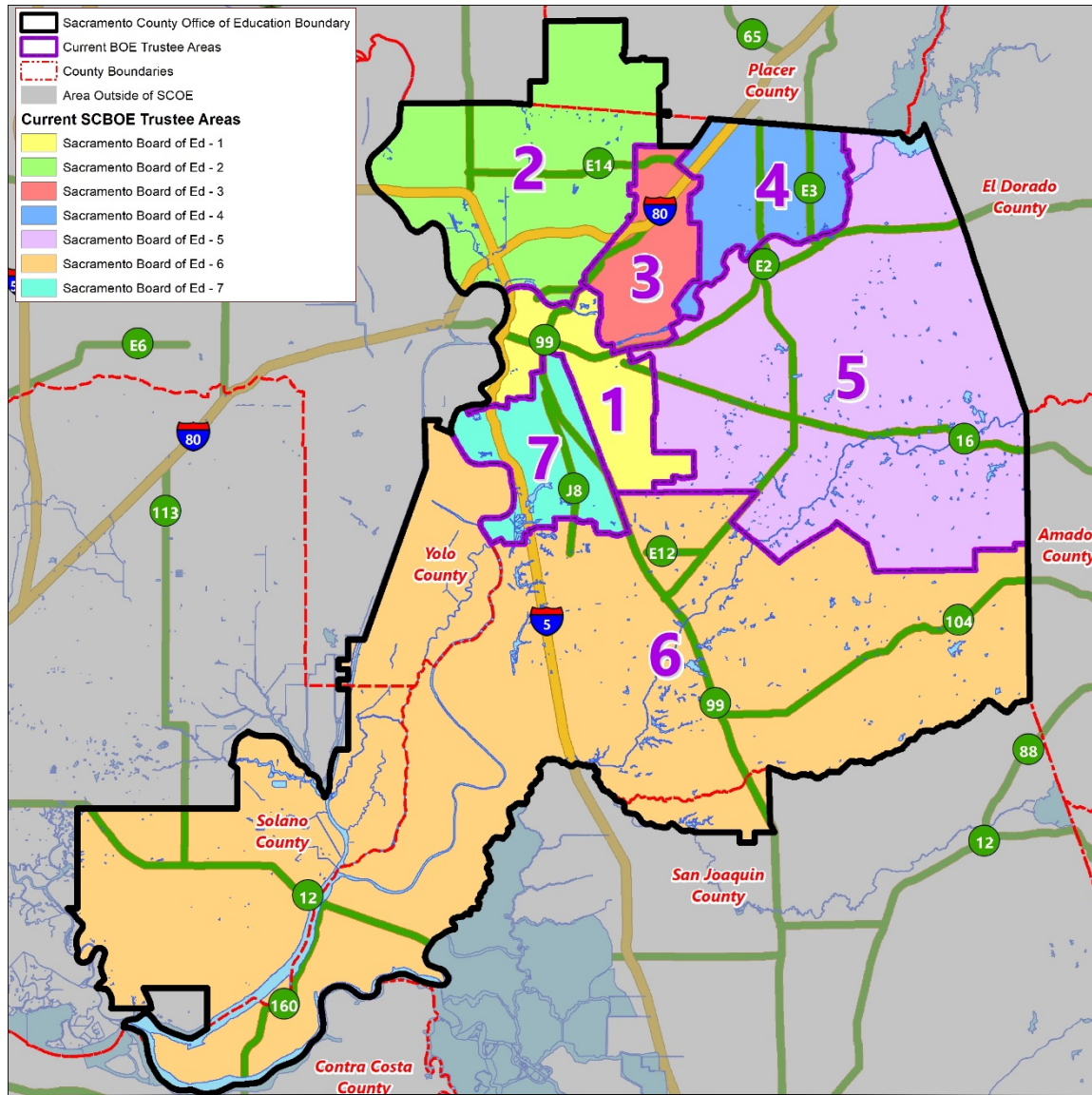

- Much more even growth in all portions of SCBOE between 2010 and 2020 Census
- Total population of each trustee area grew between 11%-14% with exception of Area 4 which only grew 5.6%

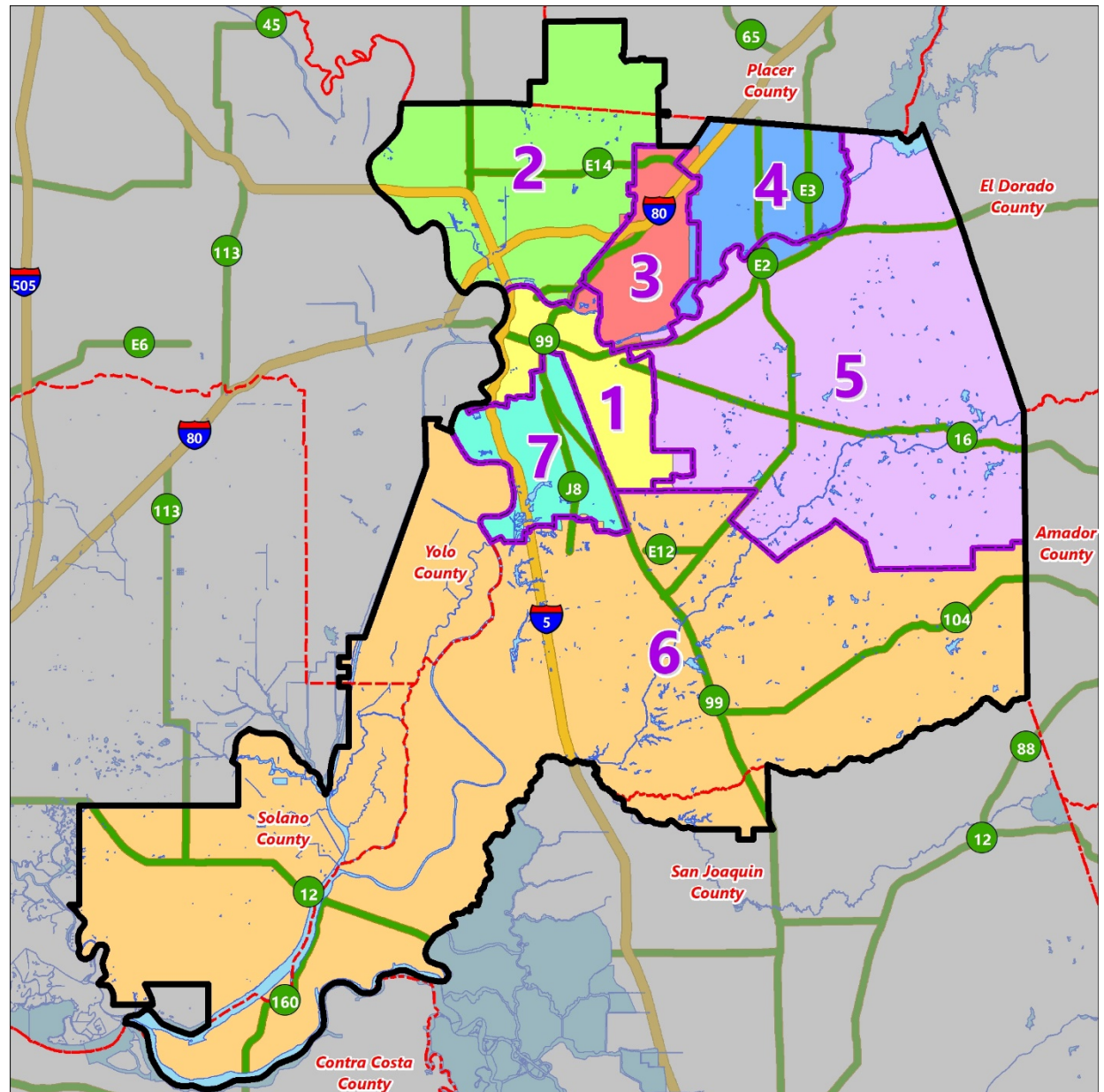
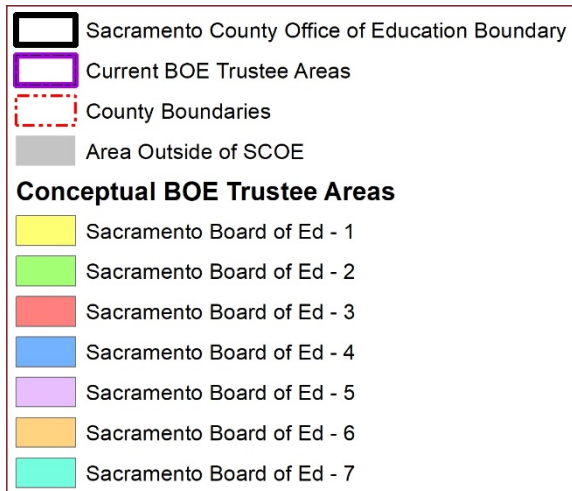

- Slightly increases share of minority populations in TA 7

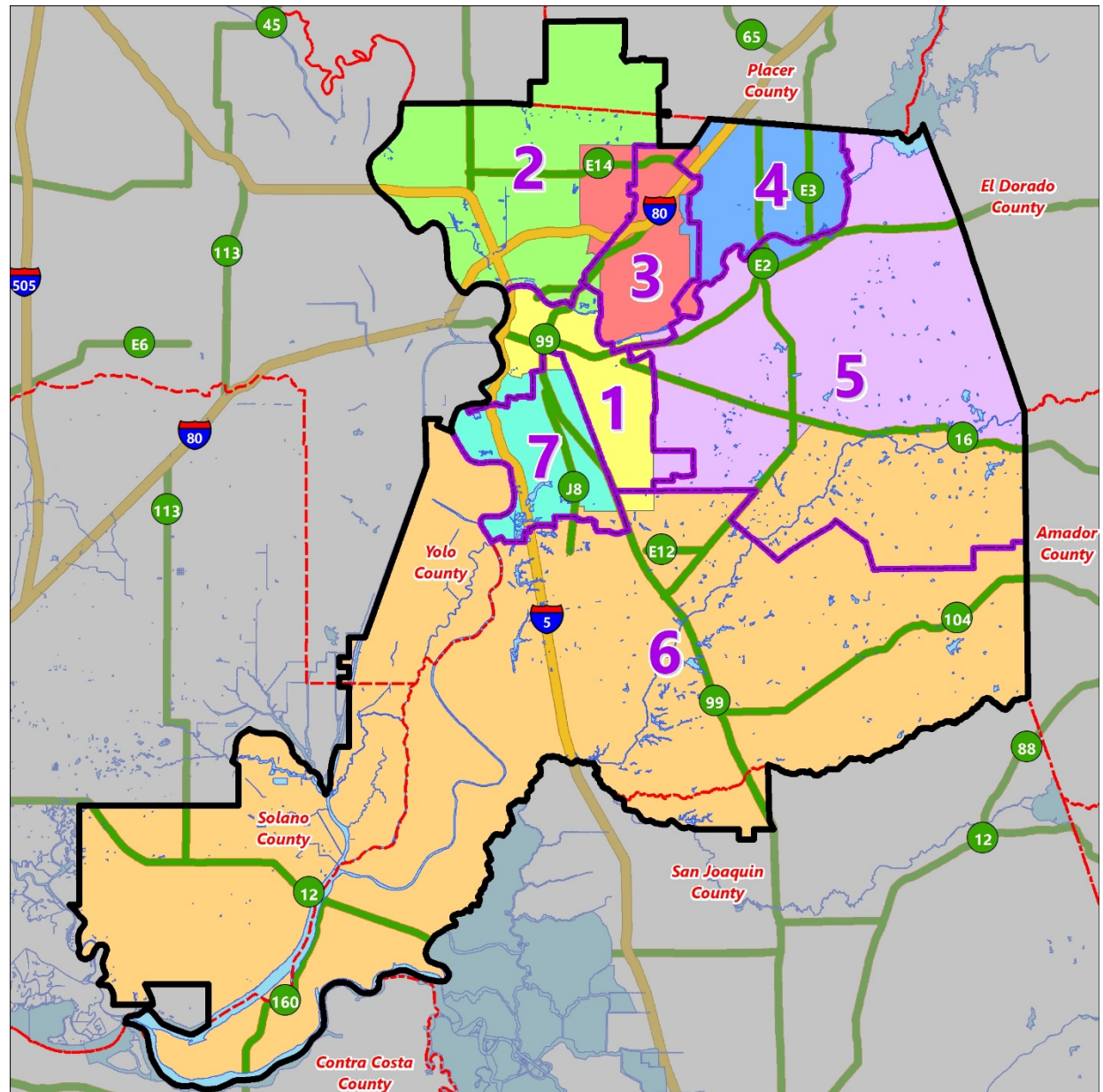
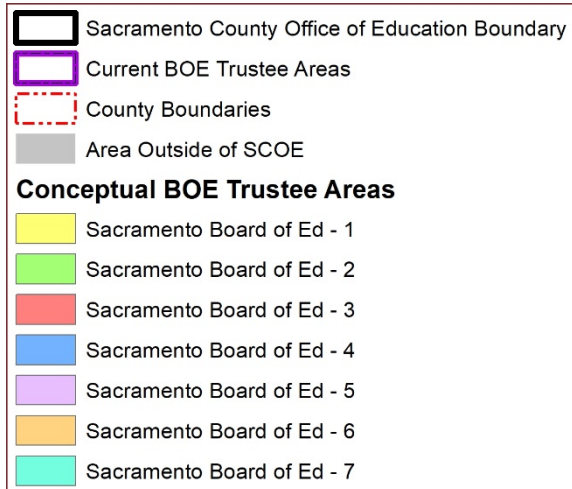

► SCENARIO 2

- Reduces variance from 8.3% to 4.0%
- American River used as boundary between TAs, except Gold River area
- Area 4 expanded to include Gold River and Carmichael areas
- Area 1 consolidated, with slight increase in Black/African American and Asian populations
- Area 7 has slight decrease in Black/African American population, but has highest Black/African American, Hispanic/Latino, and Asian populations

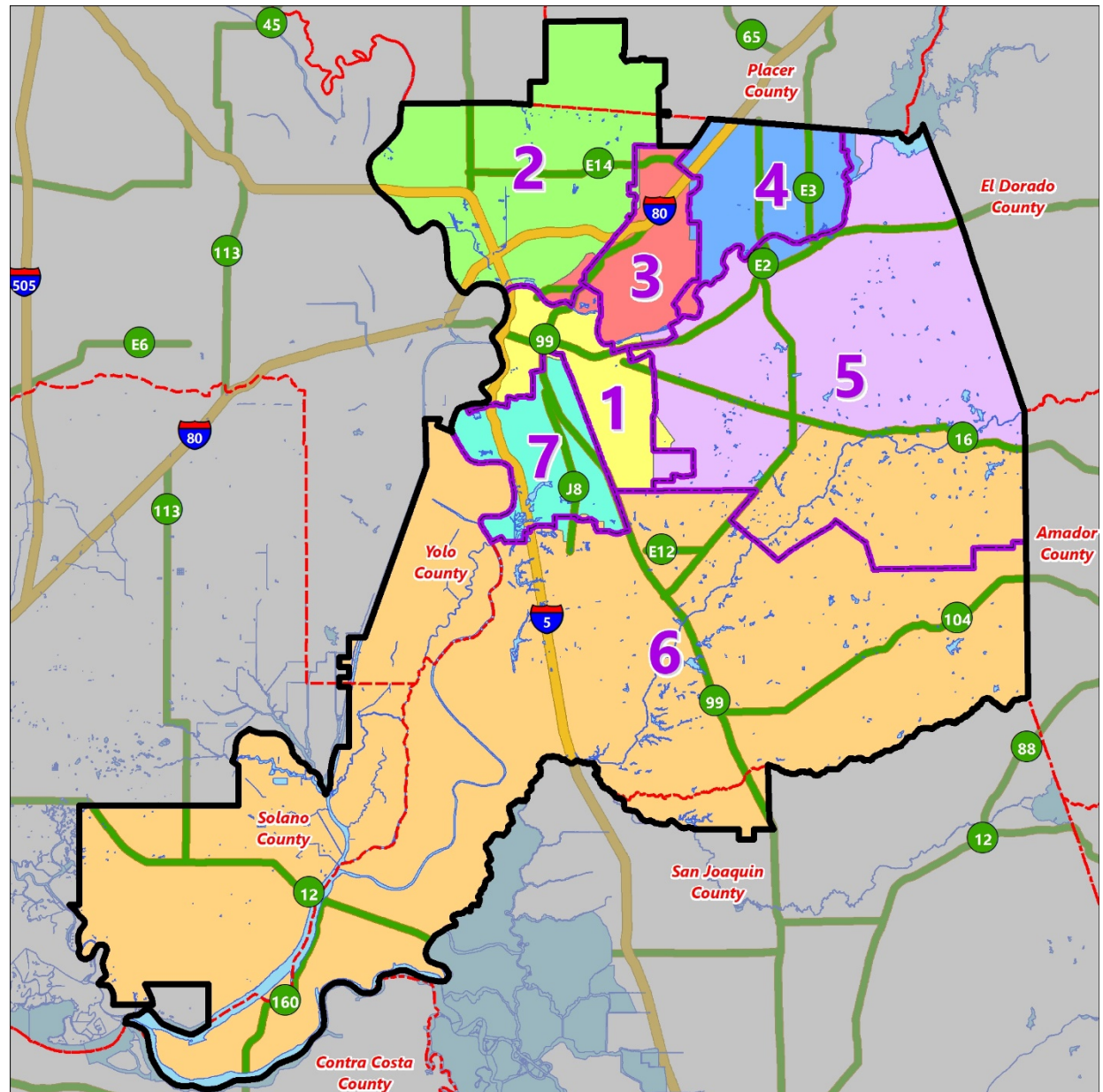
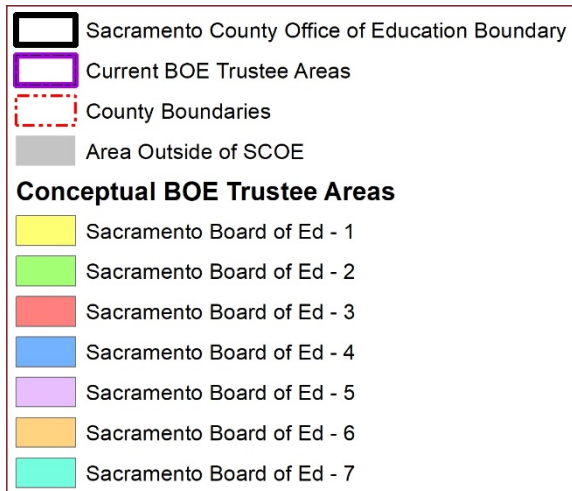

► SCENARIO 3

- Reduces variance from 8.3% to 0.4%
- American River used as boundary between TAs, except Gold River area
- Area 4 expanded to include Gold River and portion of Folsom areas
- Area 2 and 6 are least populated TAs, can accommodate growth in future
- Slight increases in Asian, Black, and Hispanic/Latino populations in Area 7
- Focus on geographic boundaries - rivers, highways, major roads, less focus on school district boundaries

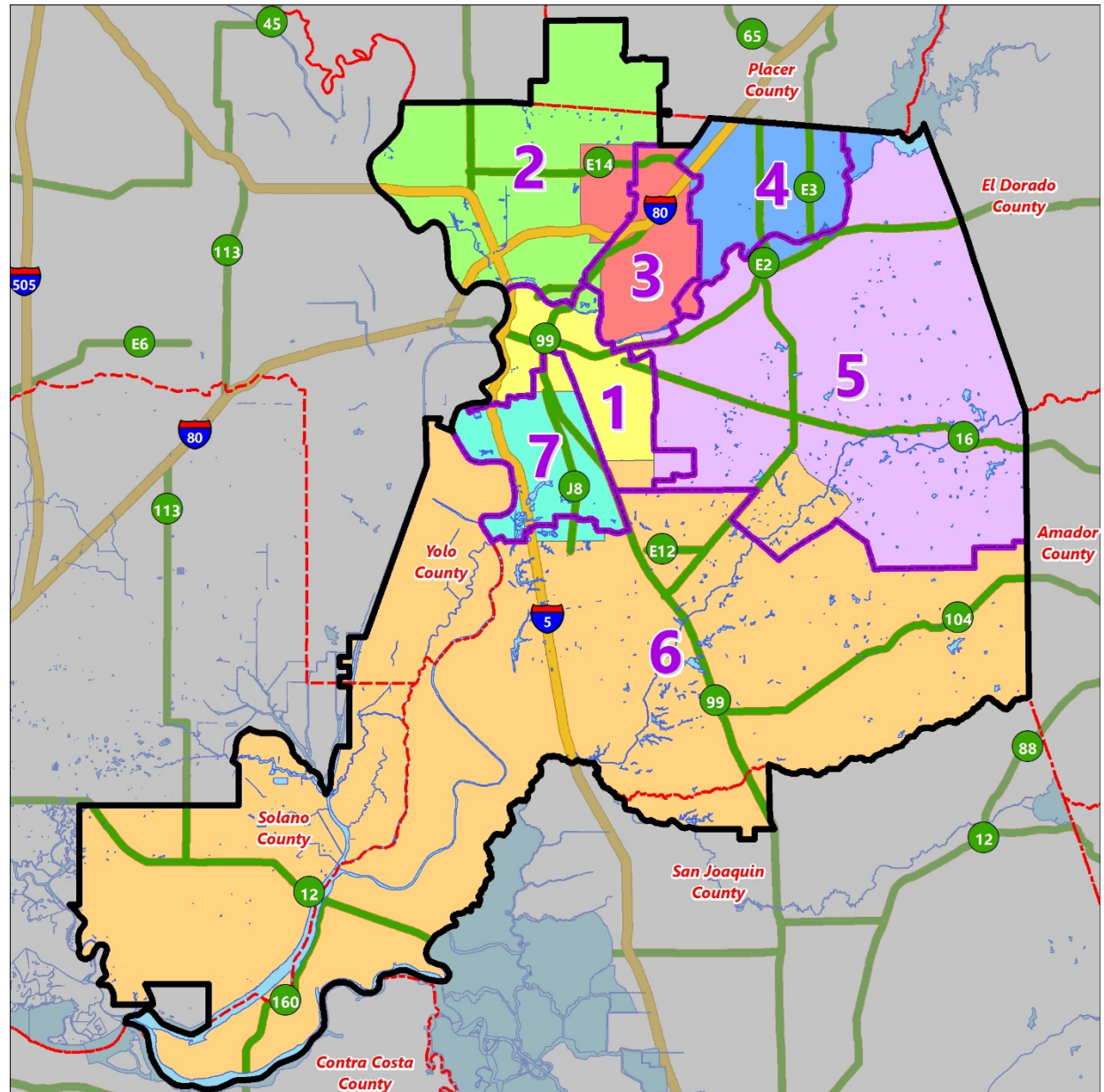
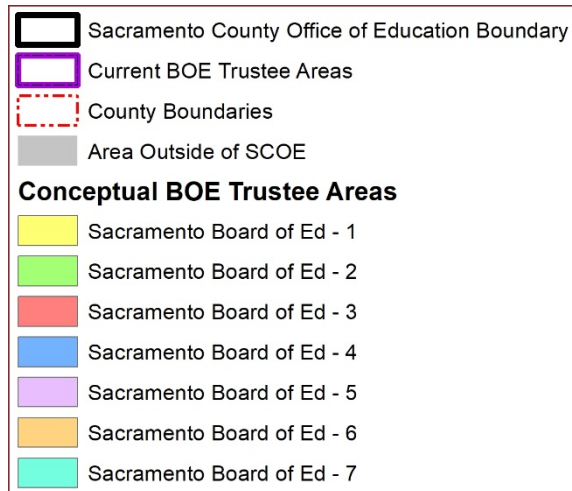

- Area 3 adjusted west to Dry Creek Rd, aligned with American River in south
- Area 1 adjusted south to Fruitridge; Area 7 adjusted south of Laguna Blvd
- Area 7 maintains highest Hispanic/Latino, African American populations and Asian CVAP
- Focus on geographic boundaries - rivers, highways, major roads.

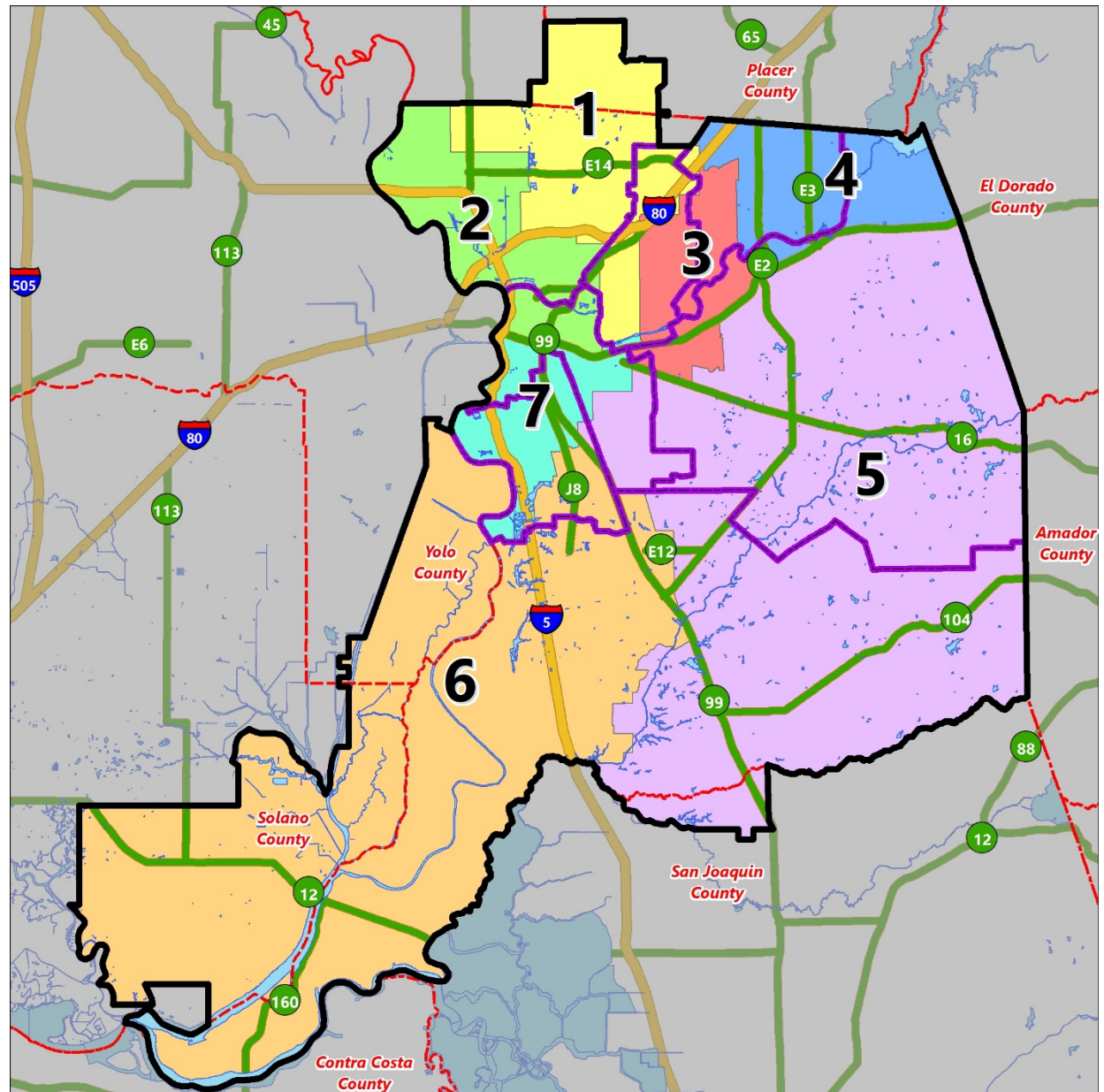
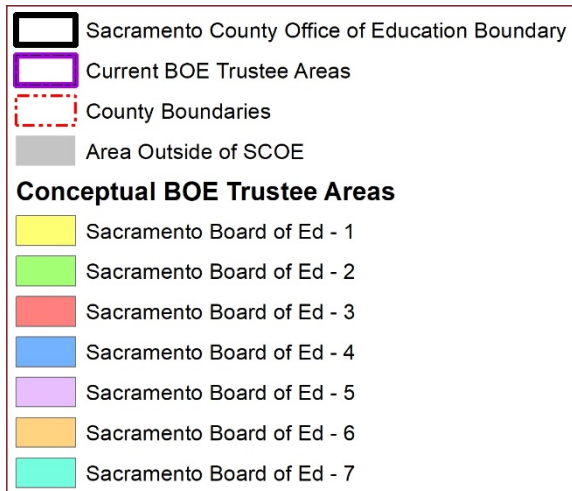

- Reduces Hispanic/Latino, Black/African American and Asian CVAP in proposed Area 1 compared to current concentrations in Area 2
