I. President Rivas called the meeting to order at 5:00 p.m. in the Board Room of the David P. Meaney Education Center, 10474 Mather Boulevard, Mather, California. Board members present were Joanne Ahola, Alfred Brown, Heather Davis, Harold Fong, Bina Lefkovitz, Jackie Levy, and Brian Rivas. Also present were David W. Gordon, Superintendent and Secretary to the Board; Al Rogers, Deputy Superintendent; and Teresa Stinson, General Counsel; other staff; and Carla Miller, Recording Secretary.

Also present were Nancy Herota, Matt Perry, and Tammy Sanchez, Assistant Superintendents; Effie Crush, Chief Administrator-Human Resources; Michael Kast, Executive Director of Special Education; Jerry Jones, Executive Director of Technology; and Tim Herrera, Director of Communications.

II. Mr. Brown led the Pledge of Allegiance.

President Rivas announced the Board would recess the meeting and convene in Closed Session regarding the Superintendent's Public Employee Performance Evaluation and Contract (other than compensation), under Government Code Section 54957, subdivision (b). The Board provided public notice that it would meet in Closed Session for this purpose.

Recessed Open Session at 5:02 p.m.

Convened Closed Session at 5:08 p.m.

Adjourned Closed Session at 6:38 p.m.

The Board convened Open Session at 6:44 p.m.

President Rivas announced that the Board took action in Closed Session, by the following vote: 7 ayes, 0 noes, 0 abstention, 0 absent, to extend Superintendent Gordon's contract through June 30, 2022.

Ms. Levy moved and Mr. Brown seconded the motion to extend Superintendent's Employment Contract through June 30, 2022. Motion carried 7 ayes based on the following Roll Call vote:

III. No Approval of Minutes

IV. Ms. Davis moved to adopt the revised agenda. Ms. Ahola seconded the motion, which carried unanimously (7 ayes).

V. There was no official correspondence.

VI.A. Dr. LaWanda Wesley addressed the Board regarding expulsion rates of African American males in K-12 and preschool. Her colleague, Dr. Luke Wood, recently published a report that was commissioned by The National Association for the Advancement of Colored People (NAACP) and featured in the Sacramento News and Review. African American males are being expelled at five times the rate of their counterparts. Some of the school districts in Sacramento County have some of the highest suspension rates in the state, including Sacramento City Unified School District (SCUSD), Twin Rivers Unified School District, Elk Grove Unified School District, and San Juan Unified School District. She hopes that SCOE can address the issue with particular districts and also at a macro level county-wide in collaboration with Sacramento constituents that care about this issue.

President Rivas stated several of us are concerned and asked her to meet with the Superintendent and see how we might be able to work together on this issue.

VI.B. There were no requests for presentations from employee organizations.

VII.A. Superintendent Gordon reported on the following:

- Congratulated Karina Talamantes and Paul Keefer who have won positions on Sacramento County's Board of Education. Karina will represent Area II and Paul will represent Area III. They will be joining us in July. Also congratulated Trustee Bina Lefkovitz who was elected to a full term on the Board to represent Area I. He thanked Trustees Brian Rivas and Jackie Levy for their work as outstanding Board members for the past eight years. We are grateful for their contributions and all they have done for students and families.

- On Saturday, June 23, the eighth graduating class of SCOE's Leadership Institute received their Preliminary Administrative Services Credential at the Sheldon High School Performing Arts Center. Seventy one aspiring administrators completed the preliminary service credential program and are ready for school leadership positions. This work aligns with our commitment to support our 13 School Districts to hire, train, and retain the best school leaders for our region's students.
- Sacramento-area students served as group facilitators for activities, program introductions, and attendee assistants at the June 18 Future Forward 2018 Youth Summit. The goal of the summit was to increase youth participation in the prevention of underage drinking and marijuana use. Trustee Lefkovitz was able to attend for part of the day.
- The SCOE Communications Office is being recognized for its work by NSPRA – the National School Public Relations Association. The staff earned a Golden Achievement Award, an Award of Merit, and three honorable mentions for projects during the past school year. The team was recognized for their work in analyzing, planning, execution, and overall communication.
- All SCOE offices will be closed on Wednesday, July 4, 2018, in observance of the Independence Day Holiday.

Superintendent Gordon, Justice Robie, Rio Americano High School Principal Brian Ginter, and Director Frank Pisi recognized Linda Reed and presented her with the June 2018 County Civic Learning Champion Award.

VIII.A. Ms. Levy moved and Mr. Brown seconded adoption of the consent agenda. Motion carried unanimously (7 ayes). By such action, the Board:

VIII.B. Ms. Ahola moved and Ms. Davis seconded approval of the contracts as listed. Motion to approve the contracts carried unanimously (7 ayes).

VIII.C. On a motion by Ms. Levy, seconded by Mr. Brown, and carried unanimously (7 ayes), the Board authorized staff to submit grant applications/service contracts and accept funding if awarded; and approved contracts, positions, and other expenditures associated with the grants as outlined in the proposed budgets as follows:

VIII.D. Ms. Lefkovitz moved and Ms. Levy seconded the motion to adopt the SCOE 2018-2019 Local Control and Accountability Plan. Motion carried unanimously (7 ayes).

Superintendent Gordon announced the collective bargaining agreements for both employee bargaining units include a 4% salary increase, effective July 1, 2018. In following past practice, managers and confidential employees, including the Superintendent per contract, receive the same provisions.

VIII.E. Approval of the 2017-2018 Budget Revision No. 3

Chair Jackie Levy of the Budget Committee stated the Budget items VIII.E. and VIII.F. are interrelated and she suggested that both items be approved together. Chair Levy recommended the Board approve the 2017-2018 Budget Revision No. 3 and adoption of the 2018-2019 proposed budget. Motion carried unanimously (7 ayes).

VIII.G. Establish July 10, 2018 as the 2018-2019 Annual Organizational Meeting Date

Mr. Fong moved and Ms. Lefkovitz seconded the motion to establish July 10, 2018 as the 2018-2019 Annual Organizational Meeting Date. Motion carried unanimously (7 ayes).

VIII.H. President Rivas announced this is the First Reading of Revisions to Board Policy 1250 – Access to County Office Sites.

Chair Al Brown of the Policy Committee recommended that the proposed revisions to Board Policy 1250 – Access to County Office Sites move forward to Second Reading at a future Board Meeting.

VIII.I. President Rivas announced this is the First Reading of Revisions to Board Policy 5125 – Pupil Records.

Chair Brown of the Policy Committee recommended that the proposed revisions to Board Policy 5125 – Pupil Records move forward to Second Reading at a future Board Meeting.

VIII.J. President Rivas announced this is the First Reading of Revisions to Board Policy 5145.3 – Prohibition on Discrimination/Harassment/Sexual Harassment; Participation of Transgender Pupils in Academic and Educational Programs and Activities.

Chair Brown of the Policy Committee recommended that the proposed revisions to Board Policy 5145.3 – Prohibition on Discrimination/Harassment/Sexual Harassment; Participation of Transgender Pupils in Academic and Educational Programs and Activities move forward to Second Reading at a future Board Meeting.

VIII.K. President Rivas announced this is the Second Reading and Adoption of Revisions to Board Policy 1312.3 – Uniform Complaint Procedures.

Chair Brown of the Policy Committee recommended the Board adopt the revisions to Board Policy 1312.3 – Uniform Complaint Procedures. Motion carried unanimously (7 ayes).

VIII.L. President Rivas announced this is the Second Reading and Adoption of Revisions to Board Policy 5610 (Renumbered 0450) – Comprehensive Safety Plan.

Chair Brown of the Policy Committee recommended the Board adopt the revisions to Board Policy 5610 (Renumbered 0450) – Comprehensive Safety Plan. Motion carried unanimously (7 ayes).

VIII.M. An informational item on the revisions to Administrative Rules and Regulations 1312.3 – Uniform Complaint Procedures was provided in the Board packet.

VIII.N. An informational item on the elimination of Administrative Rules and Regulations 5610 – School Crisis Response was provided in the Board packet.

IX.A. Ms. Davis stated she is saddened because we will be losing Trustees Rivas and Levy. She will miss both of them. She appreciated both of them and thanked them for their service. She emphasized the time and effort invested as a public figure. People see what you do in a short timeframe; however, they do not see the time spent in the evenings reading reports, driving, and attending various events and thinking about what matters the most, which is our students. Superintendent Gordon is always appreciative in announcing our attendance and efforts.

Ms. Ahola appreciated Jackie and her experience with school leadership and dedication to supporting Chef Jeff and students of the culinary program. It was such a joy to join her and her friends for lunch at the café. That support was well received by Chef Jeff. Jackie will be missed. Ms. Ahola appreciated Brian's leadership this year as a model for our Board as President and thanked him. Brian will be missed.

Ms. Lefkovitz will also miss both Trustees Rivas and Levy. Both have been so warm and welcoming, as well as giving her ideas, guidance, and answering her calls. She hopes to see them at the café. She attended the Future Forward conference. There were about 80 young people there and SCOE's Friday Club Live organized with other

nonprofits. She attended two workshops: one on being a leader and leaving a legacy, and one on using your voice through video. Students will be identifying projects in the community and applying for grants to implement their projects. They will be coming up with recommendations to present to the elected bodies in the region to discuss prevention issues. This is like Action Civics for her. She hopes they can come and present to us and share their projects and experience.

Mr. Brown stated it has been an honor working with Brian; he is the epitome of a Board member. He thanked Jackie, for all the thoughtful things she says, the way she carries herself, and the respect she demands from fellow Board members. The Board works well together as a group, and sometimes the members don't see the same way. Former Board member Greg Geeting, Brian, and Jackie had a great impact on him during his two years on the Board. He tries to bring all of his experiences to the Board. He taught at the university for 30 years, trained in Ethiopia and Nigeria, and was in the South in the civil rights movement. He has a grandson who is a student at Cosumnes Oak High School in Elk Grove. He has talked to his grandson about some of his classmates being suspended, and about when he was a student growing up in the South. He never missed a day of school and doesn't recall any classmates being suspended. His class was in a smaller private school and had 21 students. There was one person that was kicked out; later went to a public school and ended up playing pro football with the Kansas City Chiefs. Kids have a lot of issues to deal with today. They are into technology – talking to friends not only in Sacramento, but everywhere. Mr. Brown expressed his concerns about suspension rates. He is looking forward to meeting with the Sacramento Observer to discuss them. Hopefully, we can make a difference as a county board, as there's a lot of work to be done. He hopes the Board can narrow in and pinpoint where we should be putting some of our energy. We have an outstanding staff that he has learned to respect over the last two years. He is familiar with the suspension issues and is very concerned.

Mr. Fong thanked Trustees Levy and Rivas for their service on the Board. In regards to Dr. Wesley, he read the report and is shocked that the top five schools that expel kids are in Sacramento County. The expulsion of African American males is totally unacceptable and is institutional racism. He hopes through the efforts of our Superintendent and the five districts superintendents, we will come up with some plan to address this problem. We have a child care advisory committee for the county. He asked if the issue is something we can refer to our advisory committee on child care to review.

Ms. Levy stated since this is her last Board meeting as a trustee representing area III, she wanted to share the following list of SCOE programs that were started since 2010, when she first came on the Board: (1) the CARE program; (2) the SCOE School of Education; (3) WASC accreditation for our court and community schools; (4) Student Focus Groups; (5) USA Learns website; (6) Chartering the Fortune school network; (7) reinstituting the Sacramento County School Board Association semiannual dinner meetings; (8) expanding the adult re-entry program; (9) promoting Civic Education; (10) the construction and horticultural program at Palmiter and Hickey; (11) the CRANE initiative; (12) STAR camp at Sly Park; (13) Early Childhood Education programs such

as SHINE and Help Me Grow; (14) the early college program at El Centro; (15) Foster Focus and the foster youth statewide data system; and (16) the Senior Extension Program. All of this is possible because of a visionary superintendent, dedicated employees, and Board members who are committed to SCOE's mission. It has been an honor to serve on the Board, and she is immensely grateful to the citizens of Trustee Area III for their votes and their support for the past eight years.

IX.B. President Rivas thanked everyone for their kind words. It has been an honor and a privilege to serve on this Board – incredibly fulfilling. He is leaving with mixed emotions. People have asked him if he accomplished what he set out to do or if he is done – the work is not done. It hurt him that at his last meeting we are talking about the disproportionate suspension of African American young men. He would have liked to have a greater impact in that area. He lost his mother late last year and he feels a need for greater balance. He wants to leave with three things for the Board to think about: 1) continue the Robla work; 2) push on the expectations – continue to strive, and 3) invest in relationships. One more: when you run into an area of disagreement, ask the other person if they can compromise. He said thank you to all staff for supporting him. It was a wonderful experience working with everyone.

Program Description:

The Sacramento County Department of Health Services will contract with the Sacramento County Office of Education (SCOE) to expand mental health services in the Sacramento City Unified School District and the Twin Rivers Unified School District. SCOE will serve as the lead agency to support the two districts to implement the "Safe Zone Squad," an evidence-based and innovative approach to hiring and supporting school-based triage personnel and family advocates to enhance existing programs and partnerships.

This grant will increase access to a continuum of mental health services and support for middle school children and their families/caregivers on school campuses. School-based triage specialists and family advocates will work collaboratively to prevent children from developing social, emotional, and behavioral problems; provide targeted, early intervention services for children at risk; provide intensive, individually-tailored services for children with mental health needs; and provide family-based services and supports, such as assessment, brief intervention, triage and crisis intervention, linkage, and referral to services.

BACKGROUND:

Nationally, statewide and within Sacramento County there is a persistent and distressing disparity in suspension rates among student groups. African American students (and boys in particular) have been disproportionately affected by the practice. The issue of effective and appropriate school discipline practices and the disproportionate application of suspension as a consequence for student violations of school rules has long been a concern for SCOE and for communities throughout the nation.¹

Recently, the Greater Sacramento National Association for the Advancement of Colored People (NAACP) and Sacramento City College hosted an invitation-only meeting for school officials, and community members engaged in improving educational equity on July 10, 2018. During the meeting Dr. Luke Wood, from San Diego State University shared his research on Black male suspensions in California² and the recent release of a June 2018 report on Black male suspensions in Sacramento County³.

Professor Wood provided compelling evidence that much work needs to be done to reduce disproportionality in the suspension rates between Black males and their age-group peers in Sacramento County and many other counties and school districts in California.

Supporting Sacramento Districts

SCOE is supporting the continued efforts of county school districts to reduce disparities in suspension rates by providing a coherent sequence of professional learning. We are developing a comprehensive support system by examining and sharing best practices locally, across the state, and from national research-based models that provide best practices. All of these efforts are enhanced through our mandated “differentiated

assistance work with Sacramento City Unified School District, Elk Grove Unified School District, San Juan Unified School District, Twin Rivers Unified School District, River Delta Unified School District, and Robla School District.

Upon request, SCOE will also provide direct assistance to districts or schools by assigning a team of SCOE staff with expertise pertinent to the requesting district's challenges with disproportionate student suspension.

SCOE Schools

For SCOE campuses and classrooms there has been a steady decrease in student suspensions. Statewide, suspensions for all students declined from 5.7% in 2011-2012 to 3.6% in 2016-2017. During the same time period, Sacramento County's overall suspension rate for all students dropped from 8.2% to 5.7%.

Within our SCOE schools, our teams have worked diligently to reduce suspensions and exclusionary practice disparities. Examining data from the SCOE court, community, and special education schools (excluding the Fortune Charter data) we have made substantial progress reducing suspensions. The reduction in the suspension rates for students from all genders are listed in Table 1 below.

Our analysis suggests the reduction in suspension rates within the SCOE schools are due to the following improvements and partnerships:

- Improvement in instructional practice and increased student engagement
- Annual trauma-informed practice training for educators
- Collaborative analysis of school suspension data and discipline practices
- Data driven shifts in behavioral intervention practices
- Expansion of project based learning with Big Picture Learning support
- Expanding student voice due to faculty efforts and collaboration with 916 Ink, HAWK Institute, Scholastic Journalism Project, Lights of Tomorrow, Green Tech Education and Earth Mama Healing

Our Commitment

As an organization we are committed to identifying the best approach to build a sustainable support system to reduce African American male student suspensions and reduce exclusionary school discipline practices for all students within Sacramento County school districts. Our root cause analysis approach to change, includes sponsoring inquiry into the behaviors that elevate suspension rates and we anticipate offering an array of proven professional learning opportunities for our local school districts.

BACKGROUND:

The Sacramento County Board of Education is required to hold a public hearing and to determine whether each pupil in the juvenile court schools has sufficient textbooks or instructional materials, or both, in English/language arts, including the English language development component of an adopted program, mathematics, history/social science, and science that are aligned to the state content standards adopted by the State Board of Education (SBE). As part of this determination, the County Board also must determine if each pupil who is actually enrolled in a foreign language or health course has sufficient instructional materials that are consistent with the content and cycles of curriculum frameworks adopted by the SBE. In addition, the County Board must determine if pupils enrolled in a laboratory science course have adequate equipment. Detail substantiating that sufficient instructional materials are available to each student will be available for inspection by the County Board and public at the hearing.

In accordance with the sufficiency requirements of Education Code Section 60119(c), every pupil in juvenile court schools will have sufficient textbooks or instructional materials, or both, in English/language arts, including the English language development component of an adopted program, mathematics, science, and history/social science that are aligned to the state content standards adopted by the SBE. Pupils enrolled in a health course will have sufficient materials. SCOE does not offer foreign language instruction in any grades, nor does SCOE offer science laboratory courses in any of grades 9 through 12. Therefore, SCOE need not maintain science laboratory equipment. Completion of a science laboratory course is not a requirement for high school graduation, though completion of a course in either foreign language or visual or performing arts is a requirement (EC 51225.3). As necessary for completion of this graduation requirement, SCOE students are provided a course in fine arts.

McGraw-Hill Networks textbooks, recently adopted by the Board, are ordered and will be utilized by our faculty in the implementation of history/social science curriculum during the 2018-2019 school year.

SUPERINTENDENT'S RECOMMENDATION:

The Superintendent submits Board Resolution No. 16-06 for consideration and adoption, and with that adoption, the Superintendent shall submit the required certification to the California Department of Education.

August 14, 2018

WHEREAS, the Sacramento County Board of Education (County Board), governing board of the Sacramento County Office of Education (SCOE), in order to comply with the requirements of Education Code Section 60119, held a public hearing on August 14, 2018, after 6:30 p.m., which, therefore, did not take place during or immediately following school hours; and

WHEREAS, the County Board provided a 10-day notice of the public hearing posted in at least three public places within the county that stated the time, place, and purpose of the hearing; and

WHEREAS, the County Board encouraged participation by parents, guardians, teachers, members of the community, and bargaining unit leaders in the public hearing; and

WHEREAS, information provided at the public hearing and to the County Board at the public meeting detailed the extent to which textbooks or instructional materials aligned to the State academic content standards were provided to all pupils, including English learners, in SCOE juvenile court schools; and

WHEREAS, in accordance with Education Code Section 60119(c), sufficient textbooks or instructional materials were provided to each pupil before the end of the eighth week from the first day pupils attended school; and

WHEREAS, the textbooks and instructional materials currently adopted and in use in SCOE juvenile court schools are listed in Attachment "A"; and

WHEREAS, in accordance with Education Code Section 60119(c), sufficient textbooks or instructional materials aligned to the State academic content standards were provided to each pupil including English learners, in mathematics, history/social science, science, and English/language arts, including the English language development component of the adopted programs, and where appropriate, consistent with the content and cycles of the curriculum frameworks; and

WHEREAS, sufficient textbooks or instructional materials were provided to each pupil enrolled in a health course, and these materials were provided to pupils before the end of the eighth week from the first day pupils attended school; and

WHEREAS, laboratory science equipment was not provided because SCOE juvenile court schools do not provide laboratory science in any of grades 9 through 12; and

WHEREAS, SCOE juvenile court schools do not offer foreign language instruction, and the high school graduation requirement specified in Education Code Section 51225.3(a)(1)(E) is satisfied by providing pupils as necessary, a course in fine arts.

NOW, THEREFORE, BE IT RESOLVED that for the 2018-2019 school year, each pupil in Sacramento County Office of Education juvenile court schools has been provided with sufficient textbooks and/or instructional materials aligned to the State academic content standards and as appropriate, consistent with the content and cycles of the curriculum frameworks before the end of the eighth week from the first day pupils attended school as specified in Education Code Section 60119.
